AFL 2021 PREMIERSHIP SEASON (AFL AND VENUES) DIRECTIONS (NO 4) AMENDMENT DIRECTIONS (NO 2)

The World Health Organization declared COVID-19 a pandemic on 11 March 2020.

On 15 March 2020, the Minister for Emergency Services declared a state of emergency with effect from 12 am on 16 March 2020 in respect of the pandemic caused by COVID-19 pursuant to section 56 of the *Emergency Management Act 2005* (WA) (**Act**). The state of emergency applies to the State of Western Australia.

I, Colin John Blanch, Acting Commissioner of Police and State Emergency Coordinator, now give the following directions pursuant to my powers under sections 67, 70 and 72A of the Act.

PREAMBLE

1. These directions amend the AFL 2021 Premiership Season (AFL and Venues) Directions (No 4) (**Primary Directions**).

CITATION

2. These directions may be referred to as the **AFL 2021 Premiership Season (AFL and Venues) Directions (No 4) Amendment Directions (No 2)**.

COMMENCEMENT

3. These directions come into effect at the time of signing.

DIRECTIONS

4. The Primary Directions are amended by:
 - (a) deleting paragraph 34, and replacing it with the following paragraph:
 34. **Relevant person** means a person who is a relevant person under:
 - (a) the AFL 2021 Premiership Season Finals Series (Melbourne) Directions; or
 - (b) the AFL 2021 Premiership Season Finals Series (Geelong) Directions; or
 - (c) the AFL 2021 Premiership Season Finals Series (Western Bulldogs) Directions; or

(d) any other direction given by the State Emergency Coordinator


under the Act for the purpose of facilitating quarantine matches.

(b) deleting paragraph 35, and replacing it with the following paragraph:

35. **Relevant umpire** means a person who is a relevant umpire under the AFL 2021 Premiership Season Finals Series (Umpires) Directions or any other direction given by the State Emergency Coordinator under the Act for the purpose of facilitating quarantine matches.

(c) deleting Schedule 1 and inserting in its place the Schedule 1 attached to these directions.

5. For the avoidance of doubt, the Primary Directions continue in effect as in force immediately before the time specified in paragraph 3 of these directions but, from that time, as amended by paragraph 4 of these directions.
