## **Births, Deaths and Marriages Registration Regulations 1999**

### **1. Citation**

These regulations may be cited as the *Births, Deaths and Marriages Registration Regulations 1999*<sup>1</sup>.

### **2. Commencement**

These regulations come into operation on the day on which the *Births, Deaths and Marriages Registration Act 1998* comes into operation<sup>1</sup>.

### **3. Term used in these regulations**

In these regulations —

***10 year search*** means a search about a particular registrable event that is conducted in the Register, an index to the Register or both in respect of a period of 10 consecutive years or less.

### **4. Fees**

The fees set out in column 3 of the Table to this regulation are payable in respect of the corresponding matters set out in column 2 of the Table.
