AN ACT for the Closure of certain Roads and Rights-of-way and of portions of certain Roads and Rights-of-way and for other purposes.

[Assented to 5th December, 1955.]

 $B^{\rm E}$ it enacted, by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title. 1. This Act may be cited as the Road Closure Act, 1955.

2. (1) All that portion of a private street in the Albany Municipal District being—

Closure of a private street in Albany. 1955.]

Road Closure.

a street provided in a private subdivision of Albany Suburban Lot 38 and shown on Land Titles Office Plan No. 3234 as Hope Street,

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the street so closed is hereby revested in Her Majesty as of Her former estate and is removed from the operation of the Transfer of Land Act, 1893, with the intention that it be disposed of in such manner as the Governor may approve.

(1) The public road, known as Peter Street Closure of Peter Street, Alloury. 3. in the Albany Municipal District and being-

. ...

a road one chain wide extending from Middleton Road south-westward as shown on Land Titles Office Diagram No. 5680,

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the road so closed is hereby revested in Her Majesty as of Her former estate and is removed from the operation of the Transfer of Land Act, 1893, with the intention that it be disposed of in such manner as the Governor may approve.

4. (1) All that portion of a public road in the Closure of portion of Blythewood Armadale-Kelmscott Road District being-

the portion of Blythewood Avenue, Byford, between a straight line connecting the southernmost corner and the westernmost corner respectively of lots 137 and 118 on Land Titles Office Plan 3644 and a straight line connecting the easternmost corner and the northernmost corner respectively of lots 157 and 138 on that plan.

is hereby closed and all rights-of-way over it shail cease on the coming into operation of this Act.

Road Closure.

(2) The land comprised in the road so closed vests as for an estate in fee simple therein in the respective owners for the time being of the lots contiguous thereto and where the lots on opposite sides of any portion of the road so closed are owned by different owners, the contiguous half of that portion extending to a longitudinal line along the middle thereof vests in the owner or owners of the lot or lots contiguous to it.

(3) The Registrar of Titles shall, on the application of the owner of land contiguous to the part of the road so vested and on payment of the prescribed fee, cancel the relative certificate of title and issue a new one in which the land in that part shall be included.

(4) Where the land contiguous to any part of the road so vested is subject to an encumbrance, whether by way of mortgage or otherwise, as regards any estate or interest in the land, that part shall, if the nature of the encumbrance so admits, on the issue of the new certificate of title showing the vesting of the part as in this section provided, become subject to that encumbrance as if it had been originally included in the encumbrance by the owner for the time being of that estate or interest.

Closure of a certain road at Byford. 5. (1) All that portion of a public road in the Armadale-Kelmscott Road District being—

the whole of that portion of the road surrounding Reserve No. 20165 which is on the southern or western side of any point on a straight line joining the southerly alignments of Park Avenue and Park Road,

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the portion of the road so closed is hereby revested in Her Majesty as of Her former estate with the intention that it be disposed of with adjoining land in such manner as the Governor may approve. 6. (1) All those portions of a private right-of- Closure of portions of way in the Armadale-Kelmscott Road District a certain right-of-way at Byford.

- (i) that portion of the private right-of-way between lots 133 to 137 inclusive on Land Titles Office Plan 3644 and lots 153 to 157 inclusive on that plan and extending from Park Avenue to Blythewood Avenue, and
- (ii) that portion of the private right-of-way between lots 118 to 122 inclusive on Land Titles Office Plan 3644 and lots 138 to 142 inclusive on that plan and extending from Park Road to Blythewood Avenue,

are hereby closed and all rights-of-way over them shall cease on the coming into operation of this Act.

(2) The land comprised in the portions of the right-of-way so closed, vests as for an estate in fee simple therein, in the respective owners for the time being of those lots contiguous to the land and where the lots on opposite sides of any portion of the right-of-way so closed are owned by different owners, the contiguous half of that portion extending to a longitudinal line along the middle thereof vests as for an estate in fee simple therein in the owner or owners of the lot or lots contiguous to it.

(3) The Registrar of Titles shall, on the application of the owner for the time being of land contiguous to the part of the right-of-way so vested and on payment of the prescribed fee, cancel the relative certificate of title to the land and issue a new one in which the land in that part shall be included.

(4) Where land contiguous to any part of the right-of-way so vested is subject to an encumbrance, whether by way of mortgage or otherwise, as regards any estate or interest in the land that part shall, if the nature of the encumbrance so admits, on the issue of the new certificate of title showing the vesting of the part as in this section provided, become subject to that encumbrance as if it had been originally included in the encumbrance by the owner for the time being of that estate or interest.

Closure of portion of public road at Margaret River.

7. (1) All that portion of a public road at Margaret River in the Augusta-Margaret River Road District being—

the portion of a public road comprising an area of one rood two and one-tenth perches as shown coloured brown on Land Titles Office Diagram No. 10341 and connecting Town View Terrace and Forrest Road, Margaret River,

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the portion of the road so closed is hereby revested in Her Majesty as of Her former estate and is removed from the operation of the Transfer of Land Act, 1893, with the intention that it be set apart as a reserve for Park and Gardens.

Closure of Road No. 9943 8. (1) All that portion of public Road No. 9943 at Margaret River. in the Augusta-Margaret River Road District being—

> the road, the subject of Lands and Surveys Diagram No. 57898, along the southern boundary of lot 65 on Land Titles Office Plan No. 4947,

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the portion so closed shall be included in and become portion of the contiguous lot 65 on Land Titles Office Plan 4947, and shall vest as for an estate in fee simple in the owner for the time being of that lot.

(3) The Registrar of Titles shall, upon the application of the owner of lot 65, and on payment of the prescribed fee, cancel the relative certificate of Title to it, and issue a new one in which the land in the road so closed shall be included.

(4) Where the land comprised in lot 65 is subject to an encumbrance, whether by way of mortgage or otherwise, as regards any estate or interest in that land, then the land comprising the road so closed 1955.]

shall, if the nature of the encumbrance so admits, on the issue of the new certificate of title showing the vesting of the land as in this section provided, become subject to the encumbrance as if it had been originally included by the owner for the time being of that estate or interest.

9. (1) All that portion of Hamilton Street in the Closure of portion of Hamilton Bassendean Road District being-

the portion now surveyed as Swan Location 5623 on Lands and Surveys Diagram No. 63853,

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The portion so closed is hereby revested in Her Majesty as of Her former estate and is removed from the operation of the Transfer of Land Act, 1893, with the intention that the land comprised therein be disposed of by the Governor in such manner as he may approve.

10. way in the Bayswater Road Board being-

the portion of a right-of-way along the southeastern boundary of lot 47 on Land Titles Office Plan No. 2683 Sheet 1.

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the portion of the right-of-way so closed is hereby revested in Her Majesty as of Her former estate and is removed from the operation of the Transfer of Land Act, 1893. with the intention that it will be disposed of to the holder for the time being of the adjoining lot No. 47 under the provisions of the Closed Roads Alienation Act, 1932, in such manner as may be approved by the Governor.

Closure of portion of Coolgardie and Dumond Streets, Bentley.

11. (1) All those portions of public roads in the Canning Road District and being-

- (a) the portion of Coolgardie Street, Bentley, between Taree Street and the southernmost corner of lot 580 on Land Titles Office Plan No. 6419, including widenings at the northeastern end;
- (b) the portion of Dumond Street between Coolgardie Street and Palmerston Street, including widenings at either end,

are hereby closed and all rights-of-way over them shall cease on the coming into operation of this Act.

(2) The land comprised in the portions of the roads so closed is hereby vested as for an estate in fee simple in the State Housing Commission as owner for the time being of certain contiguous land.

(3) The Registrar of Titles shall, on the application of the State Housing Commission and on payment of the prescribed fee, issue a certificate of title for the land comprising the portions of the roads so closed.

(1) All that portion of Wood Street in the 12.portion of Wood Street, Claremont Municipal District being-

> the portion of Wood Street at its eastern extremity being the portion one chain wide contiguous to the southern side of lot 1 on Land Titles Offices Plan No. 581,

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the portion of the road so closed is hereby revested in Her Majesty as of Her former estate with the intention that it be included in the adjoining schoolsite reserve, No. 9111.

Closure of Road No. 4161 and certain rights-ofway at Hamilton Hill.

(1) All those portions of a public road and 13.certain rights-of-way in the Cockburn Road District being—

- (a) Road No. 4161 being a public road one chain wide extending from the western alignment of Carrington Street westerly to a line connecting the south-western and northwestern corners respectively of lots 19 and 51 on Land Titles Office Plan No. 2897;
- (b) all those rights-of-way shown on Land Titles Office Plan No. 2897 including a reserve one link wide down the western side of the land, the subject of the plan,

are hereby closed and all rights-of-way over them will cease on the coming into operation of this Act.

(2) The land comprised in the road, reserve and rights-of-way so closed is hereby vested as for an estate in fee simple in The State Housing Commission as owner for the time being of certain contiguous land.

(3) The Registrar of Titles shall, on the application of The State Housing Commission and on payment of the prescribed fee, issue a certificate of title for the land in the road, reserve and rightsof-way so closed.

14. (1) All that portion of a surveyed road in the Raymond street, Geraldton Municipal District and being— Geraldton Municipal District and being-

a road known as Raymond or Rowe Street extending from George Road along the northeastern boundary of Geraldton Suburban Lot 75 to the north-western alignment of Wittenoom Street.

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the road so closed shall by force of this Act vest for an estate in fee simple in the owners for the time being of the adjoining land and shall be reincluded in and again become portion of Geraldton Suburban Lot 76.

Road Closure.

(3) The Registrar of Titles shall on the application of the owner of Geraldton Suburban Lot 76 and on payment of the prescribed fee, cancel the relative certificate of title to it and issue a new one in which the land in the portion of the road so closed and vested shall be included.

(4) If the aforesaid lot 76 is subject to an encumbrance, whether by way of mortgage or otherwise, as regards any estate or interest in that land, then the land so vested shall, if the nature of the encumbrance so admits, on the issue of the new certificate of title, showing the vesting of such portion as in this section provided, become subject to the encumbrance as if it had been originally included in the encumbrance by the owner for the time being of that estate or interest.

Closure of portions of Road No. 9768 at Lake Preston. 15. (1) All that portion of Road No. 9768 in the Harvey Road District as shown coloured blue on Lands and Surveys Diagram No. 63496, is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the portion of the road so closed shall vest as for an estate in fee simple in the owners for the time being of Wellington Location 698 which is contiguous to the portion of the road so closed and the portion containing one rood twenty and three-tenths perches shall be included in and become part of Location 698.

(3) The Registrar of Titles shall, on the application of the owner or owners of land contiguous to the portion of the road so closed and on payment of the prescribed fee, cancel the relative certificate of title and issue a new one in which the land in the portion of the road so closed and vested shall be included.

(4) Where the land contiguous to any portion of the road so closed and vested is subject to an encumbrance, whether by way of mortgage or otherwise, as regards any estate or interest in the land, that 1955.]

portion shall, if the nature of the encumbrance so admits, on the issue of the new certificate of title showing the vesting of the part as in this section provided, become subject to that encumbrance as if it had been originally included in the encumbrance by the owner for the time being of that estate or interest.

the portion of Holly Street, Katanning, between the north-eastern alignment of Adam Street and the production south-westerly of the northeastern boundary of lot 27 on Land Titles Office Plan No. 4715, including widenings at either end.

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprises in the portion of the road so closed is hereby vested as for an estate in fee simple in The State Housing Commission as owner for the time being of the contiguous land.

(3) The Registrar of Titles shall, on the application of The State Housing Commission and on payment of the prescribed fee, issue a certificate of title for the land in the road so closed.

17. (1) All those portions of private rights-of- Closure of certain way in the Katanning Road District and being-

rights-ofway at Katanning.

the rights-of-way through the section compris-ing lots 27 to 40 inclusive on Land Titles Office Plan No. 4715,

are hereby closed and all rights-of-way over them shall cease on the coming into operation of this Act.

(2) The land comprised in the rights-of-way so closed is hereby vested as for an estate in fee simple in The State Housing Commission as owner for the time being of the contiguous land.

18. (1) All those portions of private roads in the Murray Road District being---

the roads provided in a private subdivision of part of Section A.19 of Cockburn Sound Location 16 on Land Titles Office Plan 1389, and thereon shown as Lovett, Humphreys, Shenton, Pollards and Menzies Avenues,

are hereby closed and all rights-of-way over them shall cease on the coming into operation of this Act.

(2) The land comprised in the roads so closed is hereby revested in Her Majesty as of Her former estate and is removed from the operation of the Transfer of Land Act, 1893, with the intention that the land be disposed of in such manner as the Governor may approve.

Closure of portion of a certain right-of-way in Nedlands.

19. (1) All that portion of a right-of-way in the Nedlands Road District being—

the portion of a right-of-way 25 links wide along the eastern boundaries of lots 264, 265 and 266 on Land Titles Office Plan No. 2668,

is hereby closed and all rights-of-way over it shall cease on the coming into operation of this Act.

(2) The land comprised in the portion of the right-of-way so closed is hereby revested in Her Majesty as of Her former estate and is removed from the operation of the Transfer of Land Act, 1893, with the intention that it will be disposed of to the holder or holders for the time being of the contiguous lots 264, 265 and 266 under the provisions of the Closed Roads Alienation Act, 1932, in such manner as the Governor may approve.

20. (1) All those portions of a right-of-way at Closure of a right-of-way Swanbourne, in the Nedlands Road District being— Swanbourne.

portions of the right-of-way twenty-five links wide along the western boundaries of lots 171 to 188 inclusive and lots 192 to 206 inclusive on Land Titles Office Plan 3337 and along the northern boundaries of lots 189 to 191 inclusive on the said plan,

are hereby closed and all rights-of-way thereover shall cease on the coming into operation of this Act.

(2) The land comprised in the portions so closed shall be divided into parts corresponding with the respective lots to which they are contiguous and each part shall vest as for an estate in fee simple in the owner for the time being of the lot in the subdivision on Land Titles Office Plan No. 3337 which is contiguous to that part and shall be included in and become a part of that lot. The portion of the right-of-way along the northern boundaries of lots 189, 190 and 191 shall be divided into two parts by a longitudinal line running along the middle of the right-of-way and the northern moiety shall vest in the owner for the time being of lot 188, and the southern moiety shall be divided into parts corresponding with the respective lot to which it is contiguous and each part shall vest in the respective owners for the time being of such of lots 189, 190 and 191 as is contiguous to it and shall be included in and become a part of that lot.

23. (1) All those portions of rights-of-way in the certain South Perth Road District being-

(2) The land comprised in the portions so closed shall vest as for an estate in fee simple in The State Housing Commission as owner for the time being of the contiguous lots 146 to 177 inclusive on Land Titles Office Plan No. 5137 and shall be divided into parts corresponding with the respective lots to which they are contiguous and each part shall be included in and become portion of the lot contiguous to it.
