

ROAD CLOSURE.

15° and 16° Geo. VI., No. LX.

AN ACT for the Closure of Certain Roads and Rights of Way and of Portions of Certain Roads and Rights of Way and other purposes.

[Assented to 7th January, 1952.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the *Road Closure Act, 1951*.

Closure of portion of Smeed Terrace, Bayswater.

2. (1) All that portion of Smeed Terrace in the Bayswater Road District—

bounded by lines starting from the easternmost corner of Reserve 23080; thence south-easterly along the south-western side of Rose Avenue for a distance of 5 and 5/10ths links; thence generally southerly following the curve of a circular arc having a radius of 50 links for a distance of 94 and 4/10ths links; thence 243 degrees 9 minutes 88 and 9/10th links; thence 315 degrees 25 and 5/10ths links; thence 45 degrees 1 minute 1 chain 50 links to the starting point, as shown bordered green on Lands and Surveys Diagram No. 62369

is hereby closed, and all rights of way over that portion shall cease on the coming into operation of this Act.

(2) The land contained in that portion of Smeed Terrace which is closed by the operation of the last preceding subsection is hereby revested in His Majesty as of his former estate, with the intention that it be included in the adjoining Recreation Reserve No. 23080.

3. All that portion of a public road in the Fremantle Municipal District separating Fremantle Lots 1201, 1202, 1209 and 1210 between the eastern alignment of Amherst Street and the western alignment of Wood Street is hereby closed and all rights of way over it shall cease on the coming into operation of this Act and the land comprised therein is revested in His Majesty as of his former estate.

Closure of a certain road in the Fremantle Municipal District.

4. All that portion of Marine Terrace in the Geraldton Municipal District—

Closure of portion of Marine Terrace, Geraldton.

bounded by straight lines commencing from the north-western corner of Geraldton Suburban Lot 69 and extending generally westerly, south-westerly and southerly to a southern boundary of Geraldton Lot 1373,

is hereby closed, and all rights of way over it shall cease on the coming into operation of this Act, and the land contained therein is hereby revested in His Majesty as of his former estate.

5. All that portion of Horatio Street, between Bronte and Wickham Streets, in the Perth Municipal District, is hereby closed, and all rights of way over it shall cease on the coming into operation of this Act, and the land comprised therein is revested in His Majesty as of his former estate.

Closure of portion of Horatio Street, Perth.

6. All that portion of Wickham Street, between Plain Street and Trafalgar Road, in the Perth Municipal District, is hereby closed, and all rights of way over it shall cease on the coming into operation of this Act, and the land comprised therein is revested in His Majesty as of his former estate.

Closure of portion of Wickham Street, Perth.

7. That portion of Riverside Drive in the City of Perth, and being—

all that portion of Riverside Drive between the prolongation easterly of the southern side of Nile Street and the prolongation south-easterly of the north-eastern side of Nelson Avenue,

is hereby closed, and all rights of way over it shall cease on the coming into operation of this Act, and the land comprised therein is revested in His Majesty as of his former estate.
