AN ACT for the Redistribution of Seats at Parliamentary Elections.

[Assented to 15th April, 1929.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the *Redistribution of Seats Act, 1929*, and shall come into operation on a date to be fixed by proclamation. Short title.

2. The State shall be divided into fifty Electoral Districts, each returning one member to the Legislative Assembly, and such Electoral Districts shall be designated by the names stated in the first column of the Schedule to this Act, and the boundaries of each Electoral District shall be as described in the second column of the said Schedule. Electoral Districts. Schedule.

Provided that Members of the Legislative Assembly shall continue to sit for the district represented by them at the commencement of this Act until the expiry by effluxion of time, or the sooner dissolution, of the Legislative Assembly.

3. The ten Electoral Provinces shall be designated, as heretofore, by the names stated in section six of the Constitution Acts Amendment Act, 1899, and the existing Electoral Provinces.

boundaries of such provinces at the date of the passing of this Act, as determined by the Redistribution of Seats Act, 1911, shall, until otherwise determined by Parliament, continue and be unaffected by this Act, or the proclamation whereby it is brought into operation.

Amendments to be passed by absolute majority of members of Council and Assembly.

4. It shall not be lawful to present to the Governor for his Majesty's assent any Bill to amend this Act, unless the second and third readings of such Bill shall have been passed with the concurrence of an absolute majority of the whole number of the members for the time being of the Legislative Council and the Legislative Assembly respectively.

Repeal of No. 6 of 1911.

5. Save as aforesaid, the Redistribution of Seats Act, 1911, is hereby repealed.
