

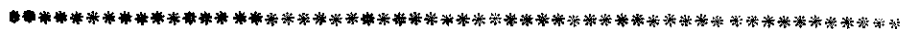

AN ACT for the Closing of certain Roads.

[Assented to 8th December, 1915.]

BE. it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the *Road Closure Act*, 1915. Short title.
2. The roads, streets, and ways, or portions thereof, described in the Schedule hereto, are hereby closed, and all rights-of-way over the same shall cease from the passing of this Act. Closure of certain roads.

THE SCHEDULE.

IN THE CLAREMONT ROAD DISTRICT.

A lane or way lying between lots 261 to 272, and lots 273 to 284 of Swan Location 537, as delineated on Plan deposited in the Department of Land Titles, No. 1140 (Vol. 281, Fol. 99).

IN THE MUNICIPALITY OF FREMANTLE.

That portion of High Street starting from the South-West corner of Fremantle Lot 1, and bounded thence by lines extending 249deg. 50min. 1 chain 23 $\frac{7}{10}$ links; thence 165deg. 11min. 55 $\frac{9}{10}$ links; thence 69deg. 55min. 1 chain 29 $\frac{1}{10}$ links; and thence 339deg. 44min. 55 $\frac{9}{10}$ links to the starting point.

IN THE MUNICIPALITY OF MIDLAND JUNCTION.

That portion of Amos Street in the subdivision of Lot 372 of Swan Location 16, lying between the production Southward of the Western boundary of subdivisional Lot 46, and the Western boundary of Lot 371, as shown on deposited Plan 2421 in the Department of Land Titles.

IN THE MUNICIPALITY OF NORTHAM.

A road or street extending from the West side of Charles Street to the East side of Morrell Street, through Northam Town Lots 174 to 179, inclusive, delineated and coloured green on a diagram deposited in the Office of Titles and numbered 3223.

IN THE CITY OF PERTH.

All those portions of Bellevue Terrace bounded by lines starting from the most Northerly corner of Perth Town Lot 465, and extending 290° 57' 67 $\frac{5}{10}$ links; thence 29° 43' 37 $\frac{2}{10}$ links; thence 2 chains 4 $\frac{9}{10}$ links, along a concave circular arc of radius 92 $\frac{4}{10}$ links, whose chord extends 93° 15' 1 chain 65 $\frac{5}{10}$ links; thence 156° 47' 3 chains 16 links; thence 1 chain 85 $\frac{6}{10}$ links along a concave circular arc of radius 1 chain 38 links whose chord extends 195° 17' 1 chain 71 $\frac{9}{10}$ links; thence 88 $\frac{1}{10}$ links along a convex circular arc of radius 1 chain 38 $\frac{4}{10}$ links, whose chord extends 215° 33' 86 $\frac{6}{10}$ links; thence 197° 19' 8 chains 97 $\frac{6}{10}$ links; thence 94 $\frac{4}{10}$ links along a convex circular arc of radius 60 links whose chord extends 152° 13' 85 links; thence 287° 8' 35 links; thence 1 chain 18 links along a concave circular arc of radius 75 links whose chord extends 332° 13' 1 chain 6 $\frac{2}{10}$ links; thence 17° 19' 9 chains 14 $\frac{5}{10}$ links; thence 66° 49' 1 chain 23 $\frac{3}{10}$ links; thence 21° 47' 35 $\frac{4}{10}$ links; thence 336° 45' 3 chains 41 $\frac{3}{10}$ links; thence 290° 57' 1 chain 10 $\frac{2}{10}$ links to the starting point.

That portion of the way from Rose Street to Leake Street (formerly John Street), North Perth, abutting on lots 19, 20, and 21 of Swan Location 653, as delineated on Plan deposited in the Department of Land Titles No. 2422.

IN THE PERTH ROAD DISTRICT.

Hillside Street, Mount Lawley, from Beaufort Street to Lawley Crescent, as shown on Plan No. 2343 deposited in the Department of Land Titles.
