

AN ACT to enable the purposes of portions of certain Permanent Reserves to be changed.

[Assented to 24th December, 1912.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:--

1. This Act may be cited as the *Permanent Reserves Act, 1912.* Short title.
2. The Governor may revoke the dedication and classification of portion of the lands comprised in Reserve $\frac{A\wedge}{11392}$, that is to say, of Toodyay lots 31 and 32, and may dedicate such lots to such purpose as he may think advisable, and classify such lots as of Class A, B, or C, as he may deem expedient. Change of purpose of portion of Reserve $\frac{A\wedge}{11392}$
3. The Reserve numbered $\frac{A\wedge}{1663}$ (South Perth) is hereby cancelled, and the land comprised therein is hereby added to and shall henceforth be a portion of the Reserve numbered $\wedge 10250$. Cancellation of Reserve $\frac{A\wedge}{1663}$

4. That portion of Reserve $\frac{A\Delta}{1720}$ which is defined in the Schedule shall, on the passing of this Act, cease to be reserved for the purposes for which it has hitherto been reserved and to be under the control of the Board of Parks and Reserves, and shall vest for an estate in fee simple in the Minister of Water Supply, Sewerage, and Drainage.

SCHEDULE.

That portion of "A" Reserve 1720 (King's Park), containing 7a. Or. 22p., bounded by lines starting from a point in the north-east boundary of Reserve 1676 (reservoir) situate 1 chain 76 links from its east corner, and extending along the reservoir fence in a north-westerly direction about 2 chains 38 links; thence $296^{\circ} 23' 45''$ 10 chains $78\frac{4}{10}$ links; thence $95\frac{2}{10}$ links along the arc of a circle having a radius of $60\frac{6}{10}$ links; thence $206^{\circ} 23' 45''$ 9 chains $84\frac{9}{10}$ links; thence $95\frac{2}{10}$ links along the arc of a circle having a radius of $60\frac{6}{10}$ links; thence $116^{\circ} 23' 45''$ 4 chains 60 links; thence 1 chain $57\frac{7}{10}$ links along the arc of a circle having a radius of 3 chains 3 links; thence $146^{\circ} 34' 2''$ chains $93\frac{5}{10}$ links to the reservoir fence aforesaid and along it north-easterly to the south-west boundary of Reserve 1676; thence north-westerly, north-easterly, and south-easterly along the south-west, north-west, and north-east boundaries of said Reserve 1676 to the starting point, as the said portion of the said Reserve is delineated and shown on plan number 15049 of the Public Works Department of Western Australia and on Resumption plan 621.
