AN ACT to authorise the Closing of certain
Roads and Streets.

[Assented to, 28th October, 1898.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. ALL rights of way on and over such roads and streets or portions of roads or streets as are described in the Schedule hereto shall cease from the passing of this Act, and Her Majesty, her heirs and successors, may deal with such portions as if they had never been public roads or streets or subject to the said rights. Abolition of rights of way.

In the name and on behalf of the Queen I hereby assent to this Act.

Closing of certain Roads.

SCHEDULE.

IN THE TOWN OF BARDOC.

All that portion of Leslie Street bounded on the *North* and *East* by lines extending $266^{\circ} 51' 5$ chains 25 links, and $176^{\circ} 51' 1$ chain 50 links from a point situate $266^{\circ} 51' 1$ chain 50 links from the South-West corner of Bardoc Town Lot 21; the opposite boundaries being parallel and equal.

All that right-of-way bounded on the *South* and *East* by lines extending $266^{\circ} 51' 25$ links, and $356^{\circ} 51' 10$ chains from a point situate $266^{\circ} 51' 4$ chains from the South-West corner of Bardoc Town Lot 21; the opposite boundaries being parallel and equal.

IN THE TOWN OF BEVERLEY.

All that portion of Taylor Street bounded by lines starting from the South-East corner of Beverley Suburban Lot 19, and extending $160^{\circ} 40' 1$ chain and $\frac{9}{16}$ of a link, thence $242^{\circ} 52' 3$ chains $3\frac{9}{16}$ links; thence $341^{\circ} 20' 1$ chain $1\frac{1}{16}$ links, thence $62^{\circ} 52' 3$ chains $2\frac{1}{16}$ links to the starting point.

IN THE TOWN OF BUNBURY.

All that portion of Wittenoom Street lying between the North side of Fraser Street and the South boundary of Bunbury Town Lot 327.

IN THE TOWN OF CARNARVON.

The whole of King Street lying between the South-East side of Robinson Street and the North-West side of Rushton Street; also all that portion of Rushton Street, one chain wide, lying between the productions South-Easterly of the North-Eastern boundary of Carnarvon Town Lot 208 and the South-Western boundary of Town Lot 229.

IN THE TOWN OF COOLGARDIE.

All that portion of Lyon Street lying between the South side of Forrest Street and the North side of Lindsay Street.

IN THE TOWN OF CUE.

The whole of Vulcan Street lying between the North-East side of Richmond Street and the West boundary of Murchison Gold Mining Lease No. 157.

IN THE TOWN OF FREMANTLE.

All those portions of Moore, Knutsford, and Broome Streets lying between the East side of Montreal Street and the West side of Carrington Street; also all those portions of Robinson, Coode, Pearse, Congdon, and Onslow Streets lying between the South side of High Street and the North side of Stephen Street, excluding the intersections of these streets with those portions of Moore, Knutsford, and Broome Streets, as closed above.

Closing of certain Roads.

IN THE MUNICIPALITY OF HELENA VALE, AND ALSO IN SUBDIVISION "E" OF SWAN LOCATION 7.

1. All that portion of Margaret Road lying between the West side of Loton Avenue and the West side of Robinson Road.
2. All that portion of Landor Gardens lying between the East side of Lot 184 and the West side of Lots 211 and 212.
3. All that portion of Lefroy Avenue lying between the East boundaries of Lots 211 and 215 and the West boundaries of Lots 216 and 220.
4. All that portion of Loftie Gardens lying between the East boundaries of Lots 219 and 220 and the West boundaries of Lots 248, 249, and 250.
5. All that portion of Ferguson Road lying between the East boundaries of Lots 248, 249, and 253 and the West boundaries of Lots 254, 258, and 259.
6. All that portion of Moore Road lying between the East boundaries of Lots 277, 278, and 283 and the West boundaries of Lots 284, 288, 289, and 290.
7. All that portion of Fairbairn Gardens lying between the East boundaries of Lots 287, 288, 289, and 290 and the West boundaries of Lots 317, 318, 319, and 320.
8. All that portion of Blackboy Flat Road lying between the East boundaries of Lots 317, 318, 319, and 323 and the West boundaries of Lots 324, 328, 329, 330, and 331.
9. All that portion of Cowan Gardens lying between the East boundaries of Lots 327 to 331, inclusive, and the West boundaries of Lots 358 to 362 inclusive.
10. All those portions of Harper Terrace and Brockman Road lying between the South side of Margaret Road and the North side of the Eastern Railway Reserve.

NEAR THE MUNICIPALITY OF HELENA VALE.

All that portion of the old York Road lying between the Northern side of the Eastern Railway Reserve and a line parallel to, and distant 50 links from, the Western boundary of Swan Location 7.

IN THE TOWN OF KALGOORLIE.

All that portion of Wittenoom Street bounded on the *North-West* and *South-West* by lines starting from a point situate $43^{\circ} 30' 1$ chain $30\frac{1}{10}$ links from the North corner of Kalgoorlie Town Lot 397, and extending respectively $43^{\circ} 30' 26$ chains 71 links and $133^{\circ} 30' 2$ chains $10\frac{1}{10}$ links; the opposite sides being parallel and equal.

IN THE TOWN OF KANOWNA.

All those portions of Gray and Golconda Streets bounded by lines starting from the intersection of the East side of Isabella Street with the North side of Gray Street, and extending $40^{\circ} 3' 5$ chains 20 links; thence $3' 2$ chains $32\frac{1}{10}$ links; thence $133^{\circ} 55' 2$ chains $77\frac{1}{10}$ links; thence $180^{\circ} 3' 39\frac{1}{10}$ links; thence $90^{\circ} 3' 41\frac{1}{10}$ links; thence $133^{\circ} 55' 2$ chains 89 links; thence $270^{\circ} 3' 9$ chains 70 links, and thence $3' 2$ chains to the starting point.

IN THE TOWN OF LAKESIDE.

All the roads, streets, and thoroughfares surveyed or shown on the plans of a Townsite of Lakeside as published by the West Australian Land Company, Limited, and dated 1889.

IN THE TOWN OF NORSEMAN.

All that portion of Morgan Street bounded on the *South* and *East* by lines extending respectively West 68 chains and North $88\frac{1}{10}$ links from a point situate East 4 chains 50 links and North 1 chain 50 links from the North-East Corner of Norseman Town Lot 570; the opposite boundaries being parallel and equal.

Closing of certain Roads.

IN THE TOWN OF NORTHAM.

All that portion of a public road, one chain wide, as shown on the plans in the Department of Lands and Surveys, the South side of which commences at the North corner of Avon Location C, and extends in an East-South-Easterly direction to the right bank of the Avon River, at the North-West corner of Northam Suburban Lot N 46.

IN THE CITY OF PERTH.

All that portion of Havelock Street, commencing at a point on the Western boundary of Perth Suburban Lot 20, distant 4 chains $92\frac{5}{10}$ links from its South-West corner, and extending $292^{\circ} 56' 1$ chain $15\frac{2}{10}$ links; thence $353^{\circ} 7' 2$ chains $28\frac{5}{10}$ links; thence $131^{\circ} 42' 1$ chain 51 links; thence $173^{\circ} 7' 1$ chain $72\frac{5}{10}$ links to the starting point.

All those portions of Samson and Parry Streets bounded by lines commencing at a point on the Southern boundary of Perth Suburban Lot 39, bearing $273^{\circ} 43'$, and distant 3 chains $96\frac{2}{10}$ links from its South-East corner, and extending $247^{\circ} 15' 1$ chain $75\frac{2}{10}$ links; thence $236^{\circ} 23' 59$ links; thence $273^{\circ} 22' 2$ chains $21\frac{2}{10}$ links; thence $55^{\circ} 46' 2$ chains 55 links; thence $118^{\circ} 18' 1$ chain; thence $93^{\circ} 43' 1$ chain $33\frac{5}{10}$ links to the starting point.

All that portion of Brown Street bounded by lines commencing at a point on the Southern boundary of Perth Town Lot 30x, bearing $93^{\circ} 40'$, and distant 3 chains $39\frac{9}{10}$ links from the South-West corner of Lot 29x, and extending $93^{\circ} 40' 1$ chain $31\frac{5}{10}$ links; thence $246^{\circ} 29' 2$ chains $17\frac{5}{10}$ links; thence $273^{\circ} 39' 1$ chain $34\frac{7}{10}$ links; thence $66^{\circ} 50' 2$ chains $20\frac{3}{10}$ links to the starting point.

All that portion of Small Street bounded by lines commencing at a point on the Southern boundary of Perth Town Lot 65w, bearing $298^{\circ} 10'$, and distant 1 chain $98\frac{7}{10}$ links from its South-East corner, and extending $243^{\circ} 1$ chain 60 links; thence $298^{\circ} 51' 99\frac{5}{10}$ links; thence $67^{\circ} 20' 1$ chain $67\frac{8}{10}$ links; thence $118^{\circ} 10' 85$ links to the starting point.

IN THE TOWN OF PINGELLY.

The whole of Pemberton Lane lying between the South side of Pasture Street and the North side of Sharow Street.

IN THE TOWN OF WONNERUP.

All that portion of Godongup Road lying between the prolongation South-Easterly of the North-East boundary of Wonnerup Town Lot 30 and a line extending $246^{\circ} 39'$ from the North corner of Wonnerup Town Lot 25.

IN THE TOWN OF WYNDHAM.

All that portion of Gambier Street lying to the West of O'Donnell Street.
