AN ACT to confirm the Expenditure for the services of the year One thousand eight hundred and seventy-four, beyond the grant for that year.

[Assented to, 21st December, 1875.]

WHEREAS by an Act of the Legislative Council, made and Preamble. passed in the thirty-seventh year of the reign of Her Present Majesty, No. 18 of 1873, the sum of One hundred and fourteen thousand, four hundred and twenty-one pounds, two shillings and sixpence was granted and applied for the services of the year one thousand eight hundred and seventy-four; And whereas there has been expended for the services of the said year, in excess of the several grants made for the several services in the account hereunto annexed, the sum of Twenty thousand nine hundred and twenty-five pounds thirteen shillings, and one penny: Be it therefore enacted by His Excellency the Governor of the Colony of Western Australia and its Dependencies, by and with the advice and consent of the Legislative Council thereof, as follows:—
