AN ACT to confirm the Expenditure for the services of the year One thousand eight hundred and seventy-one beyond the grant for that year.

[Assented to, 15th August, 1872.]

WHEREAS by an Act of the Legislative Council made and passed in the thirty-fourth year of the reign of Her Present Majesty No. 16 of 1870 the sum of One hundred and two thousand ninety-eight pounds seventeen shillings and sixpence was granted and applied for the services of the year one thousand eight hundred and seventy-one; And whereas there has been expended the services of the said year in excess of the several grants made the several services in the account hereunto annexed the sum of one thousand seven hundred and forty-six pounds five shillings and sixpence: Be it enacted therefore by His Excellency the Governor of the Colony of Western Australia and its Dependencies by and with the advice and consent of the Legislative Council thereof as follows:—
