AN ORDINANCE to facilitate the sale of Colonial Wine. [15th July, 1863.]

HEREAS sales of Wine the produce of the Colony in less quantities than five gallons are by law prohibited, unless the Vendor holds a Licence under the provisions of the Ordinance 20th of Victoria, No. 2, of 1856. And whereas such Licence does not permit the sale of such Wine in less quantity than one gallon. And whereas it is expedient that the cultivation of the Vine be encouraged by affording further facility for the sale of wine. Be it enacted by His Excellency the Governor of Western Australia and its Dependencies, by and with the advice and consent of the Legislative Council thereof:-

Preamble.

1. THAT the provisions of the Ordinance 20th of Victoria, No
20 Vict., No. 2, 1856, as
2, of 1856, regulating the duration of Licence, transfer of Licence, 1859, and this Ordinance to and mode of proceeding for recovery of penalties, shall be applicable be as One. to the Licence hereby authorized as if the said provisions were herein

repeated; and the said Ordinance, 20th of Victoria, No. 2, of 1856, as amended by the Ordinance 23rd of Victoria, No. 9, of 1859 and this present Ordinance shall, so far as is consistent with the context and objects of such Ordinances be construed as one Ordinance.

Collector of Internal Rerenue to issue Licence to retail Colonial Wine in galjan, quart, or pint measures

2. THAT it shall be competent for the Collector of Internal Revenue, if he shall deem it expedient so to do, on application to him made and on payment of a fee of One Pound, to issue to any person living in a town and keeping a store for the sale of goods or commodities, a licence, in the form set forth in the Schedule hereto, to sell by retail in such store Colonial Wine, not to be drunk on the premises where sold, in Gallon, Quart, or Pint Measures sized or marked according to the standard.

Penalty for breach of conditions of Licence.

3 THAT if any person so licensed as aforesaid shall mix or cause to be mixed any spirits or any drugs or other pernicious ingredients with any Colonial Wine sold, or exposed for sale, or deposited for sale in his store or premises, or shall fraudulently dilute or in anywise adulterate any Colonial Wine, or shall sell or offer for sale or deposit or expose in his store for sale any Colonial Wine which to the knowledge of such person has been so mixed, diluted, or adulterated, he shall forfeit any sum not less than Ten Pounds nor more than Twenty Pounds.

Colonial Wine Licences.

SCHEDULE.

FORM OF LICENCE.

Western Australia,

These are to Certify that in pursuance of an Ordinance 27th Vict., No. 14, I do hereby authorize and empower (AB) now living in the Town of and keeping a store for the sale of goods and commodities at (C) to sell therein Colonial Wine by retail in gallon, quart, and pint measures sized and marked according to the standard. And this Licence is granted upon the Condition that the wine sold be not drank on the premises where sold; and upon the further condition that the said (AB) do not mix or cause or permit to be mixed any spirits or any drugs or other pernicious ingredients in any Colonial Wine sold, or deposited or exposed for sale, in his store and premises, nor fraudulently dilute or in anywise adulterate any such wine; nor sell nor offer nor expose nor deposit for sale any such wine which to his knowledge has been so mixed diluted or adulterated. And this Licence shall continue in force until the 1st day of January next ensuing, he the said (AB) in the mean time keeping and observing the aforesaid conditions hereof.
