AN ORDINANCE to prevent Doubts as to the Legality of the "Jurors Book" for the current Year of 1860.

WHEREAS Lists of Persons qualified and liable to serve on Juries have not been prepared, published, settled and returned for the current Year in and from One or more of the Districts of the Colony, pursuant to the Provisions of "The Jury Ordinance, 1858"; And whereas the Sheriff has made up the "Jurors Book" for the current Year of 1860 notwithstanding such Irregularity, and Doubts may arise as to the Legality of such Jurors Book; Be it therefore enacted by His Excellency The Governor of Western Australia and its Dependencies, by and with the Advice and Consent of the Legislative Council thereof:—That the said "Jurors Book" for the current Year of 1860, already made up and transcribed by the Sheriff of the Colony, and kept in his Office pursuant to the said recited Ordinance, a Copy whereof is in the Schedule to this Ordinance annexed, and the "Special Jurors List" or any Jury Panel or Special Jury Panel which may have been extracted, copied out, prepared, returned, or made up respectively or which shall be extracted, copied out, prepared, returned or made up respectively from the said "Jurors Book" for the current Year of 1860,

Preamble.

The "Jurors Book" in the Sheriff's Office to be conclusive in Law notwithstanding any informality relating to the preparation of the Jury Lists.

No Jury Panel or Juror to be objected to on account of any irregularity in the Jury Lists.

shall be deemed and taken by the Commissioner of the Civil Court and the Chairman of the Court of General Quarter Sessions of the Peace and all other Officers and Persons whatsoever, to be good, valid, effectual and conclusive in Law for all the Purposes of the said recited Ordinance notwithstanding any and every List of Persons qualified and liable to serve on Juries for the current Year may not have been duly prepared, published, settled, certified or returned in strict accordance with the Provisions of the said recited Ordinance; and no Jury Precept, Jury Panel or Juror shall be objected to or be invalidated, nor shall any Challenge to the Array or to the Polls be made or allowed in any Court of Law or on any Trial, Inquest or other Proceeding, nor shall any Trial be postponed, nor any Verdict be set aside or any Judgment be arrested on account or by reason or means of any Informality, Neglect, Irregularity, Omission, Erasure, Interlineation or Error in the Preparation, Publication, Settling, Certifying, Returning or otherwise of any List of Persons qualified and liable to serve on Juries for the current Year or in the Transcription, Copying Out, or Compilation of the said "Jurors Book" or "Special Jurors List" respectively for the current Year.
