An Ordinance to provide for the payment of certain unforeseen Expenses during the year 1853, and also for the appropriation of the Revenue for the year 1854.

WHEREAS it is necessary to provide for the payment of certain Preamble.
unforeseen Expenses of the Year 1853, for which no provision has been made; and also for the Service of the Year 1854;—Be

it therefore enacted, by his Excellency the Governor of Western Australia and its Dependencies, by and with the advice and consent of the Legislative Council thereof—

I. THAT out of the produce of the Revenue of the said colony there shall and may be issued and applied to defray the Supplementary charge for the Year ending on the 31st December, 1853, and not already provided for, a sum not exceeding £9,630 1s 3d., as detailed in the annexed Schedule, No. 1.

II. AND be it enacted, that a sum not exceeding £31,091 17s. 1d., be charged upon the Revenue of the said Colony for the Service of the year 1854, and applied in the manner following; that is to say:—

III. THAT the Colonial Treasurer shall issue and pay, from Treasurer may pay
