An Act for applying certain Sums arising from the Revenue receivable in the Colony of Western Australia to the service thereof, for the Financial Year commencing First of April, One thousand eight hundred and forty-six.

WHEREAS power and authority have been vested in the Governor of Western Australia, acting with the advice and ^{Preamble.}

consent of the Legislative Council of the said colony, to make, ordain, and establish all such Laws and Ordinances as may be necessary for the maintenance of the peace, order, and good government of the same:—Be it therefore enacted, by His Excellency the Governor of Western Australia, by and with the advice and consent of the Legislative Council thereof;—That out of the produce of the Revenue of the said Colony, there shall and may be issued and applied any sum or sums not exceeding six thousand six hundred and fifty pounds, twelve shillings, and sixpence, for defraying the expenses of those Establishments chargeable on the colonial fund for the year commencing first of April, one thousand eight hundred and forty-six, as hereinafter more particularly expressed;—that is to say, any sum or sums not exceeding one hundred and seventy-five pounds to defray the salary of an Assistant Colonial Auditor, and any sum or sums not exceeding one hundred pounds to defray the salary of a Clerk to the Colonial Auditor, and any sum or sums not exceeding seventy-five pounds to defray the salary of a Surgeon at Fremantle, and any sum or sums not exceeding thirty pounds to defray the salary of the Hospital Attendant at Perth, and any sum or sums not exceeding one hundred and fifty pounds to defray the salary of the Clerk of the Councils, and any sum or sums not exceeding four hundred pounds to defray the stipends of four Clergymen, and any sum or sums not exceeding one hundred pounds to defray the salary of a Confidential Clerk in the Governor's Office, and any sum or sums not exceeding one hundred pounds to defray the salary of the Harbour-Master at Fremantle, and any sum or sums not exceeding fifty-two pounds to defray the salary of the Harbour-Master at Albany, and any sum or sums not exceeding one hundred and sixty-five pounds to defray the salary and contingent expenses of the Sheriff, and any sum or sums not exceeding one hundred pounds to defray the salary of the Crown Solicitor, and any sum or sums not exceeding one hundred pounds to defray the salary of the Registrar Clerk of Civil Court, and any sum or sums not exceeding one hundred pounds to defray the salary of the Superintendent of Rottneest Establishment, and any sum or sums not exceeding seventy-five pounds to defray the salary of a Gaoler at Fremantle, and any sum or sums not exceeding fifty pounds to defray the salary of a Gaoler at Albany, and any sum or sums not exceeding twenty pounds to defray the salary of the Bailiff of the Civil Court, and any sum or sums not exceeding twenty pounds to defray the salary of a Constable at Albany, and any sum or sums not exceeding twenty-five pounds to defray the salaries of two Constables for the district of Wellington, and any sum or sums not exceeding twenty pounds to

Treasurer to pay over salaries, &c., as the Governor shall direct.

II. AND be it enacted, that the Treasurer of the said Colony shall issue and pay the said sums to such persons, for the purposes hereinbefore mentioned, upon such days and in such proportions as the Governor for the time being by any warrant or order signed by him shall from time to time order and direct, and that the payment so made shall be charged upon and payable out of the Revenue of the said colony.

III. AND be it enacted, that the said Treasurer shall in his accounts from time to time be allowed credit for any sum or sums of money paid by him in pursuance of such warrant or order in writing as aforesaid, and that the receipt or receipts of the respective persons to whom the same shall be so paid shall be a full and valid discharge to the said Treasurer in passing his said accounts for any such sum or sums of money as shall be therein mentioned, and that he shall and do receive credit for the same accordingly.
