## **Agricultural Produce (Prescribed Agricultural Industries and Services) Regulations 2001**

### **1. Citation**

These regulations may be cited as the *Agricultural Produce (Prescribed Agricultural Industries and Services) Regulations 2001*.

### **2. Pork production industry**

- (1) For the purpose of 3(1) of the Act, the pork production industry is prescribed as an agricultural industry.
- (2) For the purpose of section 12(1) of the Act, the services referred to in that section are prescribed as services that a producers' committee may provide in relation to the pork production industry.

### **3. Beekeeping industry**

- (1) For the purpose of section 3(1) of the Act, the beekeeping industry is prescribed as an agricultural industry.
- (2) For the purpose of section 12(1) of the Act, the services in subsection (1)(b), (c), (d), (h), (l), (la), and (m) of that section are prescribed as services that a producers' committee may provide in relation to the beekeeping industry.

**4. Egg production industry**

- (1) For the purpose of section 3(1) of the Act, the egg production industry is prescribed as an agricultural industry.
- (2) For the purpose of section 12(1) of the Act, the services referred to in that section are prescribed as services that a producers' committee may provide in relation to the egg production industry.
