## **Appropriation (Capital 2015-16) Act 2015**

**No. 19 of 2015**

---

**An Act to grant supply and to appropriate and apply out of the Consolidated Account certain sums for the capital purposes of the year ending 30 June 2016.**

*[Assented to 26 August 2015]*

The Parliament of Western Australia enacts as follows:

**s. 1**

---

**1. Short title**

This is the *Appropriation (Capital 2015-16) Act 2015*.

**2. Commencement**

This Act comes into operation as follows —

- (a) sections 1 and 2 — on the day on which this Act receives the Royal Assent;
- (b) the rest of the Act — on the day after that day.

**3. Issue and application of moneys**

- (1) The sum of \$1 934 909 000 is to be issued and may be applied out of the Consolidated Account as supply granted for the year beginning on 1 July 2015 and ending on 30 June 2016.
- (2) The sum referred to in subsection (1) is additional to supply granted by the *Appropriation (Recurrent 2015-16) Act 2015*.

**4. Appropriation for capital purposes**

The sum of \$1 934 909 000 granted by section 3 as supply is appropriated from the Consolidated Account for the capital purposes expressed in Schedule 1 and detailed in the Agency Information in Support of the Estimates for the year.
