Water Services Act 2012

Water Services (Water Corporations Charges) Amendment Regulations 2015

Made by the deputy of the Governor in Executive Council.

1. Citation

These regulations are the *Water Services (Water Corporations Charges) Amendment Regulations 2015*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on 1 July 2015.
