1. Citation

These regulations are the *Western Australian Meat Industry Authority Amendment Regulations (No. 2) 2011*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on 1 July 2011.

3. Regulations amended

These regulations amend the *Western Australian Meat Industry Authority Regulations 1985*.
