Magistrates Court Act 2004

Magistrates Court (Fees) Amendment Regulations (No. 2) 2008

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council.

1. Citation

These regulations are the *Magistrates Court (Fees) Amendment Regulations (No. 2) 2008*.

2. Commencement

These regulations come into operation as follows:

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on 1 July 2008.

3. The regulations amended

The amendments in these regulations are to the *Magistrates Court (Fees) Regulations 2005*.
