Road Traffic Act 1974

Road Traffic Amendment (Novice Driver Penalties) Regulations 2008

Made by the Governor in Executive Council.

Part 1 — Preliminary

1. Citation

These regulations are the *Road Traffic Amendment (Novice Driver Penalties) Regulations 2008*.

2. Commencement

These regulations come into operation as follows:

- (a) Part 1 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day on which the *Road Traffic Amendment Act (No. 2) 2007* sections 26 and 35 come into operation.
