SHIPPING AND PILOTAGE ACT 1967

PORTS AND HARBOURS AMENDMENT REGULATIONS 1994

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Ports and Harbours Amendment Regulations 1994*.

Commencement

2. These regulations come into operation on 1 July 1994.
