JUSTICES ACT 1902

JUSTICES (FORMS) AMENDMENT REGULATIONS (NO. 2) 1993

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Justices (Forms) Amendment Regulations (No. 2) 1993*.

Principal regulations

2. In these regulations the *Justices (Forms) Regulations 1982** are referred to as the principal regulations.

Regulation 4A inserted

3. After regulation 4 of the principal regulations the following regulation is inserted —

“ **Children’s Court complaint**

4A. Where a child is to be charged under section 33 (1) (a) (ii) of the *Child Welfare Act 1947*, the charge shall be made in the form set out in Form 2. ”
