## **Retirement Villages Amendment Regulations (No. 2) 2019**

Made by the deputy of the Governor in Executive Council.

**1. Citation**

These regulations are the *Retirement Villages Amendment Regulations (No. 2) 2019*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on 1 October 2019.

**3. Regulations amended**

These regulations amend the *Retirement Villages Regulations 1992*.

**4. Regulation 4A amended**

In regulation 4A in the definition of *Code* delete “*Interim Code of Practice for Retirement Villages 2019* set out in the *Fair Trading (Retirement Villages Interim Code) Regulations 2019*” and insert:

*Interim Code of Practice for Retirement Villages (No. 2) 2019*  
set out in the *Fair Trading (Retirement Villages Interim Code) Regulations (No. 2) 2019*

**5. Schedule 1 Form 1 amended**
