## Evidence (Prescribed Persons) Regulations 2005

### 1. Citation

These regulations are the *Evidence (Prescribed Persons) Regulations 2005*.

### 2. Commencement

These regulations come into operation on the day on which they are published in the *Gazette*, or the day on which the *Evidence Amendment Act 2004* section 4 comes into operation, whichever is the later.

### 4. Office prescribed (Act s. 50B authorised officer)

(1) In this regulation —

***PathWest Laboratory Medicine WA*** means the health service provider with that corporate name established by order under the *Health Services Act 2016* section 32(1).

(2) The office of the chief pathologist in PathWest Laboratory Medicine WA is prescribed for the purposes of the definition of ***authorised officer*** in section 50B(1).
