**An Act to amend the following to extend the operation of provisions relating to the COVID-19 pandemic —**

- *The Criminal Code*;
- *the Criminal Code Amendment (COVID-19 Response) Act 2020*;
- *the Emergency Management Amendment (COVID-19 Response) Act 2020*.

*[Assented to 2 June 2021]*

The Parliament of Western Australia enacts as follows:

## **Part 1 — Preliminary**

### **1. Short title**

This is the *COVID-19 Response Legislation Amendment (Extension of Expiring Provisions) Act 2021*.

### **2. Commencement**

This Act comes into operation as follows —

- (a) Part 1 — on the day on which this Act receives the Royal Assent;
- (b) the rest of the Act — on the day after that day.

**3. Act amended**

This Part amends *The Criminal Code*.

**4. Section 318 amended**
