1. Citation

These regulations are the *Navigable Waters Amendment Regulations 2023*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published on the WA legislation website;
- (b) the rest of the regulations — on 21 December 2023.

3. Regulations amended

These regulations amend the *Navigable Waters Regulations 1958*.

4. Regulation 69 inserted

At the end of Part VIII insert:

69. Form of warrant

For the purposes of the *Western Australian Marine Act 1982* section 26(5) a warrant must be in the form of Schedule 1 Form 4.
