Made by the Governor in Executive Council.

Part 1 — Preliminary

1. Citation

These regulations are the *Health Regulations Amendment (Abortion Legislation Reform) Regulations 2024*.

2. Commencement

These regulations come into operation as follows —

- (a) Part 1 — on the day on which these regulations are published on the WA legislation website;
- (b) the rest of the regulations — on 27 March 2024.

13C. Prescribing practitioner

(1) In this regulation —

endorsed midwife means a person registered under the *Health Practitioner Regulation National Law (Western Australia)* in the midwifery profession whose registration is endorsed under section 94 of that Law.

(2) For the purposes of paragraph (b) of the definition of *prescribing practitioner* in section 202MD(1) of the Act, the following classes of registered health practitioners are prescribed —

- (a) endorsed midwife;
- (b) nurse practitioner.
