## **Health (Offensive Trades Fees) Regulations 1976**

### **1. Citation**

These regulations are the *Health (Offensive Trades Fees) Regulations 1976*.

### **2. Application**

These regulations have effect in every local government<sup>1</sup> district within the State as if they were local laws made under the Act.

### **3. Prescribed fees**

The fees set out in the Table to this regulation are payable on the registration of —

- (a) the offensive trades specified in Schedule 2 of the Act;  
or
- (b) any process or class of trade declared to be an offensive trade under section 186 of the Act.
