# **Appropriation (Consolidated Fund) Act (No. 2) 1999**

---

**No. 29 of 1999**

---

**An Act to grant supply and to appropriate and apply out of the Consolidated Fund certain sums for the services and purposes of the year ending 30 June 2000.**

*[Assented to 7 July 1999]*

The Parliament of Western Australia enacts as follows:

**1. Short title**

This Act may be cited as the *Appropriation (Consolidated Fund) Act (No. 2) 1999*.

**2. Commencement**

This Act shall come into operation on the day on which it receives the Royal Assent.

**3. Issue and application of moneys**

- (1) The sum of \$479 100 000 shall be issued and may be applied out of the Consolidated Fund as supply granted to Her Majesty for the year from 1 July 1999 to 30 June 2000.
- (2) The sum referred to in subsection (1) is additional to supply granted by the *Appropriation (Consolidated Fund) Bill (No. 1) 1999*.

**4. Appropriation of Purpose**

The sum of \$479 100 000 granted by section 3 as supply to Her Majesty is appropriated from the Consolidated Fund for the capital services and purposes expressed in Schedule 1 and detailed in the Agency Information in Support of the Estimates for the year.
