**APPROPRIATION
(CONSOLIDATED FUND) ACT
(No. 3) 1997**

No. 52 of 1997

AN ACT to appropriate out of the Consolidated Fund a sum for capital payments made during the year ended 30 June 1996 under the authority of the *Treasurer's Advance Authorization Act 1995*.

[Assented to 12 December 1997.]

The Parliament of Western Australia enacts as follows:

Short title

1. This Act may be cited as the *Appropriation (Consolidated Fund) Act (No. 3) 1997*.

Commencement

2. This Act shall come into operation on the day on which it receives the Royal Assent.

Appropriation of purpose

3. The sum of \$70 601 439.99 being payments of an extraordinary or unforeseen nature made under the authority of the *Treasurer's Advance Authorization Act 1995* and charged to the Consolidated Fund under that Act, is appropriated for the capital services and purposes expressed in Schedule 1.
