(CONSOLIDATED FUND) ACT
(No. 3) 1996**

No. 67 of 1996

AN ACT to appropriate out of the Consolidated Fund a sum for recurrent payments made during the year ended 30 June 1996 under the authority of the *Treasurer's Advance Authorization Act 1995*.

[Assented to 13 November 1996]

The Parliament of Western Australia enacts as follows:

Short title

1. This Act may be cited as the *Appropriation (Consolidated Fund) Act (No. 3) 1996*.

Commencement

2. This Act shall come into operation on the day on which it receives the Royal Assent.

Appropriation of purpose

3. The sum of \$283 678 762.28 being payments of an extraordinary or unforeseen nature made under the authority of the *Treasurer's Advance Authorization Act 1995* and charged to the Consolidated Fund under that Act, is appropriated for the recurrent services and purposes expressed in Schedule 1.
