

**APPROPRIATION
(CONSOLIDATED FUND) ACT
(No. 3) 1995**

No. 67 of 1995

AN ACT to appropriate out of the Consolidated Fund a sum for recurrent payments made during the year ended 30 June 1995 under the authority of the *Treasurer's Advance Authorization Act 1984*.

[Assented to 27 December 1995.]

The Parliament of Western Australia enacts as follows:

Short title

1. This Act may be cited as the *Appropriation (Consolidated Fund) Act (No. 3) 1995*.

Commencement

2. This Act shall come into operation on the day on which it receives the Royal Assent.

Appropriation of purpose

3. The sum of \$82 773 595.66 being payments of an extraordinary or unforeseen nature made under the authority of the *Treasurer's Advance Authorization Act 1994* and charged to the Consolidated Fund under that Act, is appropriated for the recurrent services and purposes expressed in Schedule 1.
