**ARTIFICIAL BREEDING OF
STOCK AMENDMENT ACT 1995**

No. 7 of 1995

AN ACT to amend the *Artificial Breeding of Stock Act 1965*.

[Assented to 24 May 1995.]

The Parliament of Western Australia enacts as follows:

Short title

1. This Act may be cited as the *Artificial Breeding of Stock Amendment Act 1995*.

Principal Act

2. In this Act the *Artificial Breeding of Stock Act 1965** is referred to as the principal Act.

Commencement

3. This Act comes into operation on the day on which it receives the Royal Assent.

Section 4 amended

4. Section 4 of the principal Act is amended —

(a) in paragraph (b) of the definition of “artificial breeding” by inserting after “ovum” the following —

“ or embryo ”;

(b) in the definition of “authorized ovum transplant technician” by inserting after “ovum” the following —

“ and embryo ”; and

(c) by inserting, in the appropriate alphabetical positions, the following definitions —

“

“**embryo**” means a fertilized ovum in the early stages of development;

“**ovum**” means an unfertilized female reproductive cell;

”.

Section 5A amended

5. Section 5A of the principal Act is amended —

- (a) in subsection (1) by inserting after “ovum” the following —

“ or embryo ”;

- (b) in subsection (1a) —

- (i) by inserting after “ovum” in the first place where it occurs the following —

“ and embryo ”;

- (ii) by inserting after “ovum” in the second place where it occurs the following —

“ or embryo ”; and

- (iii) in paragraph (b) by inserting after “ova” the following —

“ or embryos ”;

and

- (c) in subsection (2) by inserting after “ovum” the following —

“ or embryo ”.

Section 5B amended

6. Section 5B of the principal Act is amended —

- (a) in subsection (4) by inserting after “ovum” the following —

“ or embryo ”; and

(b) in subsection (5) by inserting after “ovum” the following —

“ or embryo ”.

Section 6 amended

7. Section 6 (6) of the principal Act is amended by deleting “semen or ova” and substituting the following —

“ semen, ova or embryos ”.

Section 9 amended

8. Section 9 (1) of the principal Act is amended by deleting, in both places where it occurs, “ova or semen” and substituting in each of those places the following —

“ semen, ova or embryos ”.

Section 10 amended

9. Section 10 (1) (ba) of the principal Act is amended by inserting after “ovum” the following —

“ and embryo ”.

Section 11 amended

10. Section 11 of the principal Act is amended —

(a) in subsection (1) (a), (b), (c), (d) and (e) by deleting, in each place where it occurs, “semen or ova”, and substituting in each of those places the following —

“ semen, ova or embryos ”; and

- (b) in subsection (4) —
 - (i) in paragraph (a) by inserting after “ovum” the following —

“ or embryo ”; and
 - (ii) in paragraph (c) by inserting after “ovum” the following —

“ and embryo ”.

Section 13 amended

11. Section 13 (1) of the principal Act is amended —

- (a) in paragraph (e) by deleting “semen and ova” and substituting the following —

“ semen, ova and embryos ”; and
- (b) in paragraph (h) by inserting after “ova” the following —

“ or embryos ”.
