### AN ACT relating to certain reserves and other lands.

[Assented to 9 December 1980.]

**B**E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the *Reserves Act 1980*. Short title.
2. (1) Reserve No. 17375, classified as of Class A, containing 24.200 6 hectares, set apart for "Recreation" and vested in the National Parks Authority is hereby amended by excising an area containing 6 033 square metres surveyed as Swan Location 10021.

(2) Reserve No. 34322, classified as of Class A, containing 1.489 3 hectares, set apart for "Recreation" and vested in the Subiaco City Council is hereby amended by including—
