

APPROPRIATION (GENERAL LOAN FUND).

No. 112 of 1985.

AN ACT to appropriate and apply from the General Loan Fund certain sums to make good the supplies granted for the service of the year ending 30 June 1986 and to supplement grants made by the present Parliament during the Second Session in adjustment of the Vote "Advance to Treasurer, 1984-85" for charges during the year ended 30 June 1985.

[Assented to 13 December 1985.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the *Appropriation (General Loan Fund) Act 1985-86*. Short title.

Issue and application of moneys.

2. There shall be issued and may be applied as supply granted to Her Majesty for the year from 1 July 1985 to 30 June 1986 the sum of \$85 023 000 from the General Loan Fund, being additional to the supply granted by the Supply Act 1985.

Appropriation of Supplies. Schedule 1.

3. (1) The sum of \$165 023 000 granted by this Act and the Supply Act 1985 from the General Loan Fund as supply to Her Majesty is appropriated from the General Loan Fund for the purposes and services expressed in Schedule 1.

Advance to Treasurer. Schedule 2.

(2) The sum of \$1 161 490.17 expended from the Vote "Advance to Treasurer, 1984-85" for charges during the year ended 30 June 1985 is appropriated from the General Loan Fund and shall be deemed to have been appropriated for the purposes and services expressed in Schedule 2.
