

# ACTS AMENDMENT (SOCCER FOOTBALL POOLS).

No. 22 of 1984.

---

**AN ACT to amend sections 84A and 85 of the Police Act 1892-1983 and section 4 of the Lotteries (Control) Act 1954-1983.**

*[Assented to 31 May 1984.]*

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

## PART I.—PRELIMINARY.

1. This Act may be cited as the *Acts Amendment (Soccer Football Pools) Act 1984*. Short title.

2. This Act shall come into operation on the day on which the Soccer Football Pools Act 1984 comes into operation. Commencement.

PART II.—POLICE ACT 1892-1983.

Citation.

3. (1) In this Part, the Police Act 1892-1983 is referred to as the principal Act.

(2) The principal Act as amended by this Act may be cited as the Police Act 1892-1984.

Section 84A  
amended.

4. Section 84A of the principal Act is amended—

(a) by deleting “and” at the end of paragraph (e);

(b) by deleting the comma at the end of paragraph (f) and substituting the following—

“ ; and ”; and

(c) by inserting after paragraph (f) the following paragraph—

“ (g) the Soccer Football Pools Act 1984, ”.

Section 85  
amended.

5. Section 85 of the principal Act is amended in subsection (4) by inserting after paragraph (aa) the following paragraph—

“ (ab) is conducted or permitted under the Soccer Football Pools Act 1984; ”.

PART III.—LOTTERIES (CONTROL) ACT 1954-1983.

6. The Lotteries (Control) Act 1954-1983 as amended by this Act may be cited as the Lotteries (Control) Act 1954-1984.

7. Section 4 of the Lotteries (Control) Act 1954-1983 is amended in the definition of "lottery"— Section 4 amended.

- (a) by deleting "or" at the end of paragraph (a);
  - (b) by inserting "or" at the end of paragraph (b); and
  - (c) by inserting after paragraph (b) the following paragraph—
    - “ (c) a soccer football pool within the meaning of the Soccer Football Pools Act 1984; ”.
