

# WHEAT DELIVERY QUOTAS.

AN ACT to amend the Wheat Delivery Quotas Act,  
1969-1973.

[Assented to 9th December, 1974.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the *Wheat Delivery Quotas Act Amendment Act, 1974*. Short title and citation.

(2) In this Act the Wheat Delivery Quotas Act, 1969-1973 is referred to as the principal Act. Act No. 114 of 1969 as amended by Act No. 90 of 1973.

(3) The principal Act as amended by this Act may be cited as the Wheat Delivery Quotas Act, 1969-1974.

Commence-  
ment.

2. This Act shall be deemed to have come into operation on the first day of October, 1974.

Long title  
amended.

3. The long title of the principal Act is amended by deleting the passage "the Wheat Industry Stabilization Act, 1968, and" in lines four and five.

Section 3  
amended.

4. Section 3 of the principal Act is amended—

(a) by adding under the passage "PART II.—  
DETERMINATION OF WHEAT DELIV-  
ERY QUOTAS." a passage as follows—

PART IIA.—SUPPLY OF INFORMA-  
TION IN SEASONS OTHER THAN  
QUOTA SEASONS. ;

and

(b) by deleting the passage "PART III.—  
MODIFICATION OF OPERATION OF  
WHEAT INDUSTRY STABILIZATION  
ACT, 1968."

Section 4  
amended.

5. Section 4 of the principal Act is amended—

(a) by substituting for the passage "Wheat  
Industry Stabilization Act, 1968" in the  
interpretation "the State Act" in subsection  
(1), the passage "Wheat Industry Stabiliza-  
tion Act, 1974"; and

(b) by substituting for the expression "III"  
in line one of paragraph (a) of subsection  
(2), the expression "IIA".

Section 5  
amended.

6. Section 5 of the principal Act is amended by repealing subsections (1) and (2).

Heading and  
section 29A  
added.

7. The principal Act is amended by adding after section 29 a heading and section as follows—

PART IIA.—SUPPLY OF INFORMATION IN  
SEASONS OTHER THAN QUOTA SEASONS.

Seasons to  
which Part  
applies.

29A. This Part applies to any season that  
is not a quota season.

8. The principal Act is amended by adding a section as follows—

Section 29B added.

29B. (1) On or after the first day of April immediately preceding any season to which this Part applies the Minister may, after consultation with The Farmers' Union of Western Australia (Inc.), direct the Committee to publish a notice in the *Government Gazette*, and in a newspaper circulating in the State, requiring all persons intending to deliver wheat of that season to the Company to supply the Committee with such information regarding the land to be used for the production of that wheat as is specified in the notice.

Minister may require information to be supplied.

(2) Any notice published pursuant to subsection (1) of this section shall contain directions as to the manner in which the information required by that notice may be supplied.

9. The principal Act is amended by adding a section as follows—

Section 29C added.

29C. Where a person supplies information to the Committee in accordance with the requirements of a notice published under subsection (1) of section 29B of this Act the Committee shall issue a letter of acknowledgement to that person and notify the Company of the issue of that letter.

Committee to issue letter of acknowledgement.

10. The principal Act is amended by adding a section as follows—

Section 29D added.

29D. All expenses, including any allowances and fees, incurred by or on behalf of the Committee in connection with the administration of this Part shall be paid out of moneys appropriated by Parliament for that purpose.

Costs of administration of this Part.

11. The principal Act is amended by deleting the heading "PART III.—MODIFICATION OF OPERATION OF WHEAT INDUSTRY STABILIZATION ACT, 1968." preceding section 30.

Heading to Part III deleted.

Section 30  
repealed.

12. Section 30 of the principal Act is repealed.

Section 31  
amended.

13. Section 31 of the principal Act is amended—

(a) by deleting the word “and” immediately after paragraph (a);

(b) by substituting for the passage “it.” in the last line the passage “it; and”; and

(c) by adding after paragraph (b) a paragraph as follows—

(c) where a notice under subsection (1) of section 29B of this Act has been published in relation to a season to which Part IIA of this Act applies the Company shall not, except with the consent in writing of the Minister, receive wheat of that season other than wheat produced by a person who has supplied the information required by that notice and been issued with a letter of acknowledgement under section 29C of this Act.
