

# MOTOR VEHICLE (THIRD PARTY INSURANCE).

AN ACT to amend the Motor Vehicle (Third Party Insurance) Act, 1943-1970.

[Assented to 10th December, 1971.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the *Motor Vehicle (Third Party Insurance) Act Amendment Act, 1971.*

Short title and citation.

(2) In this Act the Motor Vehicle (Third Party Insurance) Act, 1943-1970, is referred to as the principal Act.

2. Subsection (1) of section 3 of the principal Act is amended by substituting for the passage, "section ten of the Workers' Compensation Act, 1912-1944" where it occurs in lines three, four and five of each of paragraphs (a) and (b) of the definition "Approved insurer", the passage, "section thirteen of the Workers' Compensation Act, 1912" in each case.

3. Section 4 of the principal Act is amended—

(a) by substituting for the passage, "First offence, Two hundred dollars. Subsequent offence, Four hundred dollars" in the penultimate and last lines of paragraph (a) of subsection (3), the passage, "First offence, Four hundred dollars. Subsequent offence, Eight hundred dollars"; and

(b) by substituting for the words, "One hundred dollars" in the last line of paragraph (c) of subsection (7), the words, "Two hundred dollars".

4. Subsection (4) of section 10 of the principal Act is amended by substituting for the passage, "Penalty: Ten dollars" in the last line, the passage "Penalty—Twenty dollars".

5. Subsection (2) of section 28 of the principal Act is amended by substituting for the words, "two hundred dollars" in the last line, the words, "four hundred dollars".

6. Subsection (2) of section 33 of the principal Act is amended by substituting for the words, "forty dollars" in line two of paragraph (e), the words, "eighty dollars".
