## NOTES ABOUT THE WESTERN AUSTRALIAN NATIONAL GAS ACCESS LAW TEXT

The Western Australian National Gas Access Law text is the text that results from modifying the National Gas Law, as set out in the Schedule to the National Gas (South Australia) Act 2008 (South Australia) for the time being in force (the SA Schedule), as shown in the National Gas Access (WA) Act 2009 Schedule 1 (WA Schedule 1) and to reflect that, because of the National Gas Access (WA) Act 2009 s. 7A, amendments to the SA Schedule only affect the Western Australian National Gas Access Law text to the extent that they are declared under that section to be relevant to that text.
