## P r o c l a m a t i o n .

*By His Excellency JOHN HUTT, Esquire, Governor and Commander-in-Chief of the Territory of Western Australia, and Vice-Admiral of the same.*

Whereas by the first section of an Ordinance passed in this present year, intituled “An Ordinance to make provision for the “Trial of Criminal Offences at Albany and “other remote Districts of the Colony of “Western Australia,” it is enacted that Courts of General Sessions of the Peace

for the various Districts of this Colony may be holden at such times and in such places as the Governor shall by Proclamation from time to time appoint;—Now therefore I, the Governor, by this my Proclamation, appoint that Courts of General Quarter Sessions may be holden at Albany on the second Wednesday in February, the second Wednesday in May, the second Wednesday in August, and the second Wednesday in November in each and every year until further notice.

In consequence of the great increase of late of Dogs in the possession of the Natives, and the frequent injuries which they inflict on the flocks of the colonists, the Governor has been pleased to offer a reward to Constables of One Shilling for the head of each Dog, and of Sixpence for the head of each Puppy, henceforth found in the possession of any of the aboriginal race.

These rewards to be paid on the certificate of a Magistrate, that the head for which the reward is claimed has been destroyed in his presence.

His Excellency requests attention to the fact, that the evil complained of arises almost entirely from the baneful practice of the settlers giving young dogs to the natives.
