ROADS about Northam, Newcastle, and Bejoording.

*Surveyor General's Office,
Perth, 2nd July, 1867.*

IT is hereby notified, that Public Roads have recently been surveyed, laid out, and marked for general use, according to descriptions hereunder given.

1.—Newcastle to Goomaling.

The road to be 1 chain wide on the north side of posts placed at each angle. Commencing at a spot on the Bejoording line from Newcastle about 14 chains NW from the Newcastle bridge, the road extends in a general Easterly direction 2½ miles, and NE 1¼ miles to Nunile Spring, then SE by S nearly a mile and ENE 1 mile in-

side the South boundaries of Avon location 350 and of tillage lease 1905, then nearly 2 miles SE by E and 1 mile NE to the NW corner of location W, and finally in a general North-easterly direction about 22 miles, passing on the North side of Muggamuggin Rocks, through the West corner of location 116 at Mombekine, through the SE corner of location 89 at Babakine, through location 451 to its North boundary, and outside of the North boundaries of locations 451 and 256 to the North corner of the latter near Goomaling Spring:—All bearings magnetic.

2.—Twine's Road.

From Sinclair's Ford through the Avon River to the Bejoording road from Northam. The road to be half a chain wide on South side of posts placed at each angle. From the East end of Sinclair's Ford the road extends nearly a mile ENE inside the Northern boundary of Avon location U1, then $1\frac{1}{4}$ miles in a general ESE direction to a spot on the East boundary of U1 bearing WSW from Twine's house in location 32, then generally E by S $1\frac{1}{4}$ miles and ESE $2\frac{1}{2}$ miles to South corner of location W, passing through location 32 between its South corner and Twine's house, and through locations U and T2 and T1, and finally 1 mile ENE along the inside of the South boundary of location W to the Bejoording road from Northam:—All bearings magnetic.

3.—Bejoording Road.

Between Northam and Bejoording; being portion of the line less minutely described in a Government Gazette notice bearing date 12th July, 1855. The road to be 1 chain wide on the West side of posts placed at each angle. From the North end of Short street in Northam the road extends 42 chains in direction nearly N by W $\frac{1}{2}$ W to a spot outside of and near to the NW corner of Lockyer's paddock in Avon location R, thence 29 chains NW $\frac{3}{4}$ W and 49 chains NNW $\frac{1}{2}$ W to the junction of a short branch road from SSW, thence 46 chains N $\frac{3}{4}$ E into location e, thence 41 chains NNW and 28 chains N $\frac{1}{4}$ E to North boundary of e and South end of Chitibin road, thence generally NW by N 121 chains to a spot on South boundary of location W, 85 chains ENE from its West end, passing previously between the North corner of location 403 and the South corner of 168, and through the Western part of 440 and 444, then 230 $\frac{1}{2}$ chains NW $\frac{1}{4}$ W, NNWesterly, and N by E $\frac{1}{2}$ E to a spot on the Western boundary of W 120 chains ENE from that location's WNW corner, then 150 chains N NW into location 406 and 60 chains N $\frac{3}{4}$ E through the West corner of location 341 to the crossing with Goomaling road at NW corner of location W. Thence the road extends generally N $\frac{1}{2}$ W for 5 miles and NW $\frac{1}{2}$ N for $4\frac{1}{2}$ miles to a spot near the mile of the South boundary of Bejoording Townsite, having previously passed through the North East corner of location 4:—All bearings magnetic.

4.—Rossland Road.

Nunile to Culham. The road to be half a chain wide on the West side of posts placed at each angle. From the Goomaling line at Nunile Spring the road takes a general NNE direction for 1 mile through location U3, then NNW $2\frac{1}{4}$ miles along the inside of the East boundaries of U3, 12 and 11 into 1a, then generally NW by N, N by W $\frac{1}{2}$ W, and WNW for about 5 miles, through locations 1a and 4, to a spot near Culham house on a road laid out by Mr. R. Austin between Toodyay and Bejoording Townsites:—All bearings magnetic.

5.—Quelquelling Road.

Northam to Quelquelling. The road to be 1 chain wide on the North side of posts placed at each angle. From the North corner of Northam Suburban lot No. 1, the road extends about 24 chains NE to a spot near the West side of what is known as P. Chidlow's grave, in Avon location P1, and thence about NNE 64 chains and N $\frac{1}{2}$ E 46 chains, through locations P1, P2 and Q, passing along the East side of F. Morrell's fenced fields and to a spot near the East boundary of Q, thence nearly $1\frac{1}{2}$ miles generally NE $\frac{1}{2}$ N, through location 8 to SE corner of location 87 at Noggogerin, thence 58 chains NNW along the East side of locations 87 and 51, thence 250 chains generally N by E through the East corner of location 304 and West corner of P4, thence $5\frac{1}{2}$ miles NE through East corner of location 410

to the West side of Cartamulligin Rocks, and finally $4\frac{1}{2}$ miles generally NE $\frac{1}{2}$ E to the East corner of 326 at Quelquelling, passing outside of the South boundary of that location:—All bearings magnetic.

6.—Chitibin Road.

Northam to Goomaling Road. The road to be half a chain wide, on the West side of posts placed at each angle. From that part of Bejoording road where it crosses the North boundary of Avon location e, the road extends $2\frac{1}{2}$ miles generally NNE, passes through Avon location 441 and through the East corners of locations 385 and 377 to East corner of location 328, then $3\frac{1}{4}$ miles generally N by E to South corner of location 320, and generally NNW $3\frac{1}{4}$ miles, outside the West boundaries of locations 320 and 290 (at Chitibin), to the Goomaling road on Western side of the Muggamuggin Rocks:—All bearings magnetic.

7.—Beerling Road.

Between Chitibin and Quelquelling Roads. This branch road to be 1 chain wide on North side of posts placed at each angle. Commencing at a part of the Chitibin road about 14 chains North from where it crosses the North boundary of Avon location e, this road extends $\frac{3}{4}$ of a mile NE and ENE to a branch of Mortlock River 30 chains NNW from Avon location 8, then $2\frac{1}{4}$ miles generally ENE, and joins the Quelquelling road about 30 chains S by W from East corner of location 304:—All bearings magnetic.

8.—Jurendine Road.

Eastward from Noggogerin. This road to be half a chain wide, on the South side of posts placed at each angle. Commencing at the Quelquelling road at South corner of Avon location 88, this road extends nearly a mile ENE, and passes outside the South boundaries of locations 88 and 305, then nearly $2\frac{1}{4}$ miles in the average direction NE by E, passing through location P3 to its North corner, and finally ENE about 53 chains, along the South side of the South boundaries of locations P4 and 362, to the East corner of the latter near Jurendine Spring:—All bearings magnetic.

9.—Lockyer Road.

Through Avon location R. This short branch road to be half a chain wide, on the North side of posts placed at each angle. From a part of the Bejoording road about $1\frac{1}{4}$ miles NNW from Northam Town boundary, the road extends SSW about 15 chains, WSW about 60 chains, and generally South about 28 chains, to a road between Northam and Wash Pool, near right bank of Avon River, laid out by Mr. R. Austin:—All bearings magnetic.

10.—Sewell Road.

Northam Bridge to Wash Pool Ford. This road to be half a chain wide, on South side of posts placed at each angle. Commencing at the Northam Bridge over Avon River, the road extends NW by N and NW by W about 90 chains to the West corner of Avon location C, then generally WNW and Westwards $2\frac{1}{2}$ miles to a fork in Austin's marked road near left Bank of Avon River to the South-eastward of Wash Pool Ford:—All bearings magnetic.

THE following Instructions for the guidance of Inspectors of Sheep, in the performance of their duties, under the "Scab in Sheep Ordinance of 1866," are published for general information.

INSTRUCTIONS TO INSPECTORS OF SCAB.

I.—Correspondence.

1. All Correspondence and Communication with the Government will be carried on through the Colonial Secretary.

II.—Act and Regulations.

2. The Inspector will be bound to keep copies of the "Scab in Sheep Ordinance of 1866," and of all duly authorised Regulations or Instructions under the same, which he will produce when required by the Owner of any sheep which he may be inspecting.

III.—Accounts and Returns.

3. The Inspector will make all his Communications to owners and others in writing whether in the shape of Notices, Instructions, or Decisions, copies of which he will in all cases retain; and he will deliver all such notices and decisions to the parties interested, personally, or at their residences, or transmit them to their respective addresses by letter through the post.

4. In replying to official correspondence, the Inspector will give not only the date of such communication, but also the numbers and letters (if any) which it may bear; and when any enclosure to be returned is received, he will note and attend to its contents, and return it without delay to the person by whom it was forwarded, keeping copies, if necessary.

5. All correspondence and reports by him should be expressed in clear and concise terms, and should be written in a legible hand, on foolscap paper, with one third margin.

6. The Inspector shall keep a journal or record of the employment of his time, and of the state of the health of the flocks in his district, from which he will, at the end of each month, make up a return to the Colonial Secretary in the form of Schedule E hereof.

7. Every Inspector, where necessary, will receive a book of license forms, with corresponding butts, which on the granting of a license, he will fill up and retain; and he will also be furnished with a like book of renewed license forms, which he will fill up when required, in the same manner as that of license forms and butts.

8. On the receipt of any fees for a renewed license, or of any moneys paid to him under the Act, on public account, the Inspector shall make the necessary entries in his cash book, and he will, at the end of every calendar month, transmit the amount of such fees and moneys direct to the Resident Magistrate of the district in which he is located, who will forward the same to the Colonial Treasurer.

9. Immediately after the 30th of June and 31st of December in each year, the Inspector, to whom such renewed license forms have been sent, will prepare and transmit to the Colonial Secretary a balance sheet, in the usual form shewing the number of license forms received, and the number of licenses and renewed licenses issued by him during the past half year, and the number of forms on hand for the ensuing half year.

10. On retirement or removal from his appointment, the Inspector will hand over to his successor, or to the nearest Resident Magistrate, all public records, books, acts, regulations, or other documents or papers in his possession, relating to the duties of his office.

IV.—Inspections.

11. The Inspector will provide himself with a proper "Scab glass," and will make himself thoroughly acquainted with its use and the best mode of detecting the *acarus*, or scab, if present.

12. In examining sheep the Inspector will exercise the greatest vigilance and care; 1st—That he makes all possible inquiry as to the probability of the infection reaching the sheep which he is examining; 2nd—That all the sheep belonging to the flocks which he is inspecting are presented to him for examination; 3rd—That every such sheep comes under his eye during the inspection; 4th—That he stops and examines every sheep shewing the slightest symptoms of the disease; and 5th—That on handling any sus-

pected sheep he carefully examines, both with the naked eye and with the "Scab glass," every portion of such sheep on which the disease is likely to shew itself.

13. The first and most important duty of the Inspector, after that of preventing the spread of the disease, is to detect its existence immediately on its outbreak; and he should for this purpose not only endeavour to gain the earliest possible information of its doing so from third parties, which, as well as the names of such parties, must be kept strictly private, but he must keep up such a systematic round of inspection of the flocks in his district as would render it impossible for the disease to exist for any length of time without his detecting it.

V.—Information of Disease.

14. The Inspector will likewise, so far as lies in his power, obtain reliable information as to the state of the flocks in other districts in the Colony; and he will convey any information of importance he may obtain in this respect to the neighbouring Inspectors.

15. On becoming aware of the outbreak of the disease in any new locality, the Inspector will at once communicate the fact to the Colonial Secretary, and he will also convey to him any other information or suggestion connected with the duties of his office which he considers would be for the benefit of the public.

VI.—Infected Carcasses, Skins, or Wools

16. In and around those districts where the infection exists, it will be the duty of the Inspector while it does so, and for some months afterwards, to be especially careful that no carcasses of sheep are left on runs or roads undestroyed, and that sheepskins and wool, on being conveyed from these districts, are, during the period stated, properly packed and secured.

VII.—Outlay and Expenses.

17. He will in no case incur any outlay or expense, not expressly permitted by the Act or these Regulations, without having first asked and obtained the sanction of the Governor thereto.

2.—ENFORCEMENT OF PENALTIES.

18. As it is the duty of the Inspector to see that the provisions of the Ordinance are carried out in their integrity, he will be vigilant to detect any breach or evasion of these provisions, and, on his doing so, he will at once lay an information before the Resident Magistrate of the district in which he is located, against the offender, with a view to enforce the penalties that may be incurred.

19. On laying an information for the recovery of any penalty or sum of money under the Ordinance, the Inspector will, without delay, communicate the fact of his doing so to the Colonial Secretary, and will transmit to him, at the same time, a full statement of the case.

3.—INFECTED SHEEP.

I.—Examination and Quarantine.

20. The Inspector, on finding that any sheep are infected, will see that the requisite notices are given by the owner, and that the caring for and branding of the sheep are attended to; and he will then, without delay declare the run of the owner of such infected sheep, whereon the same are for the time being depasturing, as and to be the boundary within which the whole of such infected sheep shall be kept in quarantine, and deliver the requisite notice in the form of Schedule A hereof.

II.—License and Supervision of Cleansing.

21. On application being made to him by the owner of infected sheep, the Inspector will, without fee, grant such owner a license in the form of Schedule B hereof, for the period of six calendar months from that date, and on a like application and payment by the owner of the authorised fees to the Inspector, he may grant a renewed license, also in the form of Schedule B, for a period of three months; and it will be his duty not only to attend and see that the process of cleansing such sheep is properly carried out, but also to visit the sheep thus under license at

intervals, and especially when the weather is such as would cause the disease, when present, to shew itself.

III.—*Avoidance of License.*

22. The Inspector in serving any owner with notice of the avoidance of his license or renewed license, will do so in the form of Schedule C hereof, and should he think such a step to be necessary, he will apply to two Justices of the Peace for authority to destroy the sheep named in such license or renewed license.

IV.—*Clean Certificate.*

23. On receiving notice from the owner of any sheep which had been infected, that they are then clean, and that they have not exhibited any symptoms of Scab since they were last dipped, with an application from such owner for a certificate declaring his sheep to be now free from infection, the Inspector will, if he is not already acquainted with the correctness of such notice, make a thorough inquiry into the case, and will carefully inspect the sheep, for which such application is made, in the manner hereinbefore directed, and if he be then satisfied that the facts are as therein stated, he will, but not otherwise, grant the necessary certificate declaring such sheep to be clean in the form of Schedule D hereof.

4.—TRAVELLING SHEEP.

I.—*Inspection and Notice to next Inspector.*

24. It will be the duty of the Inspector to examine all sheep travelling through or near his district, and to see not only as to the state of their health but also that all the requirements of the Ordinance are fully complied with.

II.—*Examination on detention and disposal of Sheep.*

25. On the Inspector receiving notice from their owner of the detention of any travelling sheep he will at once proceed to examine them, and if he should decide that such sheep are infected he will immediately take the following steps, namely:—

- 1.—He will destroy all such as are actually infected with the disease.
- 2.—He may if he thinks it proper so to do, direct that such of the sheep as may not be actually infected with the disease, be driven back to the run from whence they came, or he may, in his discretion, permit them to proceed to their original destination, provided that by so doing, he is certain that no risk whatever will be incurred of infecting sheep depasturing in the districts through which they may travel.
- 3.—The Inspector may, in the event of the owner of the sheep failing to comply with the direction to drive them back to the run from whence they came, destroy the same.

5.—IMPORTED SHEEP.

Inspection and Clean Certificate.

26.—On receipt of a report from any person who may import sheep into the Colony, the Inspector will at once examine the sheep so imported, and if it should appear to him, after a thorough inspection of the same, that they are not infected, he will, but not otherwise, grant a Certificate accordingly in the forms of Schedule D hereof.

6.—CONTRIBUTIONS

Check on Returns by Owners.

27.—The Inspector will ascertain and enter in his journal, the actual number of sheep on the several stations in his district, and the names of their respective owners; and he will compare the returns made by such owners to the Clerks of Petty Sessions, with the actual numbers thus ascertained by him; and if it should appear on such comparison that any owner failed to make a return, or to do so at the appointed time, or made an incorrect return, the Inspector will at once lay an information against such owner, and enforce payment of the correct amount of contribution, with expenses and penalties.
