FIRST NOTICE.

I.—CHAMPION BAY AND GREENOUGH.

Bounded on the *North* by a line from King's Table Hill Trigonometrical Station due West to the sea coast. On the *Eastward* by a line from the last-named Trigonometrical Station through White Peak, Mount Fairfax, Wizard Peak, Mount Hill, Mount Horner, and Strawberry Stations, to the Irwin River. On the *Southward* by the said river to location 595, and by a line due West from that location to the sea coast; and on the *Westward* by the coast.

II.—IRWIN PLAINS.

Bounded on the *Northward* by a line from Nagade Spring Eastward to Coal Seam; thence *Southward* by lines to Mount Melara and Mount Scratch; thence *Westward* to Muggawa; thence *Northward* to Yaragadee and Nagade Spring (the commencing point.)

III.—GINGIN.

Bounded on the *North*, *South*, *East*, and *West* by lines equidistant four miles, from the intersection of the main road in Gingin Township with the Brook, and being a block eight miles square.

IV.—CHITTERING.

Bounded on the *Northward* by locations 98, 287, and 324; and on the *Southward* by location 102 (known as Goyamin). On the *Eastward* and *Westward* by lines two miles apart, and both equidistant from the main road and Chittering Brook.

V.—AVON, EAST SIDE OF YORK TO  
BEJOORDING.

Bounded on the *Northward* by a line running Eastward for six and half miles from the South-east corner of location 5 (E. Macintosh), and in continuation of its Southern boundary; thence *Southerly* to the North-eastern corner

of location A (near York); thence by the Northern boundary of that Section to the River Avon; and by that river and the Tood-yay Brook to the commencing point.

#### VI.—WEST MOUNT BAKEWELL, YORK.

Bounded on the *Southward* by locations Y 16 and Y 22. On the *Eastward* and *Northward* by locations K, Y 10, Y 11, Y 12, Y 13, 321, 322; and on the *Westward* by a line due North from the North-west corner of location Y 16.

#### VII.—BADGING, SOUTH-EAST YORK.

Bounded on the *Northward* by a line bearing 62 deg. 30 min. E. true, having the Northern boundary of location 274 at Badging Spring in the centre, and extending Easterly and Westerly for one mile from that point in each direction; the *Eastern* and *Western* being at right angles to the *North* boundary, and parallel to each other, and having a length of five miles; and the *Southern* boundary being five miles South of and parallel to the Northern first mentioned.

#### VIII.—WEST OF BEJOORDING.

Bounded on the *Southward* by the Northern boundaries of Avon locations 20 and 35. On the *Westward* by a line of about three hundred and forty-one chains, extending Northwards in continuation of the Western boundary of location 35. On the *Northward* by an Easterly line of about two hundred and five chains to the West boundary of Avon location 5; and on the *Eastward* by that location's Western boundary.

#### IX.—MOORUMBINE.

Bounded on the *Northward* by a line about one mile Northward. On the *Westward* by a line about three quarters of a mile Westward. On the *Eastward* by a line about a mile and half Eastward; and on the *Southward* by a line three miles Southward from centre of Avon location 126, at Moorumbine.

#### X.—COWRING.

Bounded on the *Eastward* by a line extending Northward about two and half miles from the North-west corner of Cowring Reserve near Boommull, and by a South line from said spot, of about three miles. On the *Northward* by a Westerly line from Northern end of East boundary to the River Mackie. On the *Southward* by a Westerly line from the Southern end of the East boundary to the said river, and by the River downwards to the West end of Northern boundary.

#### XI.—BEVERLEY.

Bounded on the *Northward* by the townsite of Beverley and freehold lands. On the *Southward* by a line running East and West from the forks of the Avon. On the *Eastward* and *Westward* by lines running on an average of one mile from both banks of the river.

#### XII.—AVON DISTRICT (*Caldwell's*).

Bounded on the *North* and *East* by lines extending West 25 chains and South 40 chains from a spot 5 chains East and 20 chains North from Naramucking Gully, which is situated about North 212 degrees East from Woodebulling Hill, and by opposite boundaries parallel and equal; all bearings true or thereabouts, and measurements more or less.

#### XIII.—AVON WEST.

Bounded on the *Eastward* by location 3, on the Avon River. On the *Northward* and *Southward* by lines on an average one mile distant from the said river, and running *Westward* for about three miles.

#### XIV.—WANDERING.

Bounded on the *Southward* by the Hotham River. On the *Eastward* by a line running due North and South one mile East of the mouth of Wandering Brook. On the *Northward* by a line running due East and West through Michibin Hill; and on the *Westward* by a line running due North and South one mile and a-half West of the mouth of Wandering Brook.

#### XV.—MOORAPULLING AND MURRAY RIVER.

Commencing at the junction of the Bannister and Hotham rivers, going down the river to

Moorapulling Brook junction, then up that brook for eight miles, having an average breadth of one mile, with the river and brook in the mean centre.

#### XVI.—BANNISTER.

Bounded on the *Eastward* by the townsite of Bannister. On the *Westward* by freehold lands, and having a mean depth of half a mile from both banks of the Williams River.

#### XVII.—WILLIAMS RIVER.

Bounded on the *Eastward* by Williamsburgh townsite, having an average breadth of one mile and a-half, with the Williams River in the mean centre between, and extending Westerly to the junction of the said river with the Hillman River.

#### XVIII.—WILLIAMS (*Albany Road*).

From the 105 mile post to 140 mile post, with a width of half a mile on both sides of the Road.

#### XIX.—WILLIAMS (*Holdway's*).

Bounded on the *North* and *East* by lines extending West 30 chains and *South* 33 chains 33 links from the North-west corner of the Reserve round Wardering Spring; the opposite boundaries being parallel and equal, and bearings true or thereabouts.

#### XX.—LAKE CLIFTON (*Pouracre's*).

Bounded on the *Eastward* by the Road from Bunbury to Peel. On the *Southward* by a line Westward from the 32 mile post on the said road. On the *Westward* by Lake Clifton, with the contiguous and adjoining swamps; and on the *Northward* by a line running due East and West from the North end of the aforesaid lake.

#### XXI.—WATERLOO.

Commencing on the main road from Bunbury to Perth, by Logue's, at seven miles from Bunbury Post Office, and extending along the Road Northward for two miles, with a depth of sixty chains on each side of road.

#### XXII.—PRESTON, NORTH.

Bounded on the *Northward* by a line due East from the North boundary of Wellington location 54 for twenty miles; thence Southerly at a right angle to the Preston River. On the *Southward* and *Westward* by the said river.

#### XXIII.—PRESTON, SOUTH.

Bounded on the *Northward* by the Preston River. On the *Eastward* by a line due South from a point one mile East of Minninup Bridge. On the *South* by a line ten miles from the Northern boundary, and running due East and West; and on the *Westward* by a line parallel to, and five miles distant from, the Eastern boundary.

#### XXIV.—BUNBURY COMMONAGE.

All that land known as Bunbury Commonage.

#### XXV.—VASSE (*near Wonnerup*).

Bounded on the *Northward* by part of the South boundary of Wellington location 46, commencing at the North-east corner of location 213, in a Westerly direction to its South-west corner; thence along the West boundary of that location; thence in a South-westerly direction along the boundary of location 41 to Sussex location 9; thence by a true South line of six miles. On the *South* by a true East line of about four miles and a-half. On the *East* by a true South line from the South-east corner of Wellington location 213 before mentioned, until it meets the South boundary.

#### XXVI.—KOJONUP (*Albany Road*).

From 156 to 162 miles on the Albany Road, with a width of two miles on both sides of the said road.

#### XXVII.—ETEKUP (*East of Kojonup*).

Being a rectangular block of five thousand acres around Etekup.

#### XXVIII.—LAKE MATILDA (*Albany Road*).

From the 200 miles on the Albany Road Southwards to location 27 (Hassell's), having a breadth of half a mile, on the East side of the said road.

THE following By-laws for the establishment and control of a Market in Perth, compiled and passed by the Perth Municipal Council, have been confirmed by His Excellency the Governor, with the advice of his Executive Council.

By-laws for the Establishment and Control of a Market in Perth.

PREAMBLE.

WHEREAS it is necessary that a General Daily Market should be established in the City of Perth, it is resolved by the City Council, in accordance with the Municipal Council Act of 1871, that such Market be established, and the following By-laws for the Regulation and Management thereof be adopted, and take effect from the first day of June, 1872:—

DESIGNATION AND APPROPRIATION.

1. That such Market be called the Perth General Market, and the site of such Market be such spaces under the Town Hall, and in the immediate vicinity thereof, as may be set apart for such purpose from time to time by the City Council.

2. The Market shall be open every day in the year, excepting Sundays, Christmas Day, and Good Friday, from sunrise to sunset, except on Saturdays, when it shall remain open until 9 o'clock, p.m.

INSPECTOR.

3. That there shall be appointed for the said Market an Officer, to be called the Market Inspector, whose duties shall be to see that all By-laws for the regulation of such Market be duly observed. To take charge of the Scales and Standard Weights and Measures of such Market, to have such Weights and Measures legally stamped, and all others used in the Market adjusted thereby, receiving for every Weight or Measure so adjusted the sum of three pence. To inspect all Weights and Measures used in the Market, and to seize such as are found to be fraudulent or defective. To inspect all articles exposed for sale in the Market, and to seize such as are bad or unwholesome; and on such articles being surveyed by any two members of the City Council, and declared by them in writing to be bad or unwholesome, to cause the same to be destroyed, and to prohibit the sale of any articles in such Market which may be considered noisome or offensive.

LOCALITY OF MARKET.—RENT.—CHARGES.

4. That such spaces as may be devoted to the purposes of the Market shall be appropriated for the sale of Wares, Merchandise, Dairy and Farm produce. That the following fees be charged for the use of such spaces, and which fees shall in every case be paid in advance, viz.:—

- I. Offices fronting Howick Street, at the rate of £12 and £15 respectively, per annum, payable quarterly.
- II. Stalls or spaces under the Town Hall of about 100 superficial feet, from Five shillings to Seven shillings and sixpence per month, according to position. Unappropriated stalls or spaces, sixpence per day, or portion of a day.
- III. Stands for carts, &c., at the rear of the Town Hall, or such place as may be appointed by the Council, One shilling per day or portion of a day; for Barrows and the like, sixpence per day or portion of a day.

ALL GOODS TO BE SOLD BY AVOIRDUPOIS WEIGHT.

5. That all Butter, Potatoes, Grain, &c., shall be sold by Avoirdupois weight; and no other weight shall be allowed in the Market.

Any person offering to purchase may require the vendor of such goods, &c., to weigh the same, and if on reference to the Market Inspector it shall be found that such vendor has made a false representation of the weight thereof, every such person shall forfeit and pay any sum not exceeding forty shillings for every such offence.

GOODS TO BE WEIGHED IN STALL.

6. All Weighing or Measuring of goods by Stall-holders shall be performed within such Stalls.

OCCUPIERS OF STALLS NOT TO OBSTRUCT.

7. That any person who may place any matter or thing so as to obstruct the roadways and passages in the said Market, or elsewhere therein than where desired by the Inspector, and shall neglect or refuse to remove the same on being required to do so by the Inspector, shall forfeit and pay any sum not exceeding forty shillings for every such offence.

PEGS, NAILS, OR HOOKS TO BE DRIVEN IN THE BUILDING.

8. That any person who may place any hook, nail, or peg in any part of the stone, brick, or woodwork of the Building, or may in any way fit up or enclose any Stall without the consent or contrary to the direction of the Inspector; or if any stall-holder neglect or refuse to take down any nail, hook, peg, or fittings, in his or her Stall, when required to do so by the Inspector, every such person shall forfeit and pay any sum not exceeding forty shillings for every such offence.

PENALTIES FOR SWEEPING DUST IN THE GUTTERS.

9. That any person who may sweep or cause to be swept any dust or rubbish into or upon any of the roadways or gutters of the said Market, and allow the same to remain there, shall forfeit and pay any sum not exceeding forty shillings for every such offence.

STALLS TO BE KEPT CLEAN.

10. That the holders of any Stall or shed in the said Market who may fail or neglect, within one hour after the opening of such Market, to thoroughly cleanse his or her Stall, and the gutter or roadway in front thereof, or who shall fail or neglect to keep or leave such Stall, &c., in good order, shall forfeit and pay for every such offence any sum not exceeding forty shillings.

POULTRY TO BE KEPT IN COOPS.—CATTLE AND HORSES NOT TO BE SOLD.

11. All live Poultry for sale in the Market must be kept in coops with rail bottoms, and supported by legs raised one foot six inches from the ground; and no live Pigs, Sheep, Cattle, or Horses shall be kept for sale in the Market.

BUTCHER'S MEAT NOT TO BE SOLD.

12. No Butcher's Meat or Fish shall be offered or exposed for sale in any part of the Market; excepting that on Saturdays Fresh Pork may be sold in the Market, subject to an extra charge of one shilling to a Non-Stall-Holder.

AUCTIONEERS TO OBTAIN A LICENSE.

13. Any person who shall act as Salesman or Auctioneer in the Market, without first obtaining the authority in writing of the Chairman of the City Council to do so, shall forfeit and pay the sum of forty shillings.

HAY AND STRAW TO BE REMOVED.

14. All Hay or Straw to be removed from the Market before 3 o'clock, p.m.; any owner of such Hay or Straw failing to do so, shall forfeit and pay any sum not exceeding Five Pounds, together with expense of removal.

GOODS TO BE REMOVED, IF NECESSARY.

15. Occupiers of Stalls, if required by the Inspector to do so, must remove all goods of an objectionable nature every evening at the close of the Market; and all goods left during the space of eighteen hours unclaimed, shall be disposed of, under instructions of the Chairman of the City Council.

## FINES FOR DRUNKENNESS, &amp;c.

16. Any person who may go into or appear in the said Market in a drunk or disorderly state, or excite any riot or disturbance, or curse or swear, or use any gross or abusive or indecent language, or be guilty of any gross or indecent conduct, or smoke therein, shall forfeit and pay any sum not exceeding Five Pounds for every such offence.

17. That any person who may resist the Inspector in the discharge of his duty, shall, independently of any penalty which he or she may incur for assault or otherwise, forfeit and pay the sum of forty shillings.

18. The opening and closing of the Market will be announced by the ringing of a bell; and it is to be distinctly understood that the City Council will not be responsible for the safety of any goods brought for sale to the Market, or which may be left there at night by permission of the Inspector.

19. For every offence against any of the provisions of these By-laws, the penalties shall be enforced in a summary way before any Justice as shall by law be required.

THE following Localities have been defined as the Educational Districts for the Kojonup and Northam Districts:—

## K O J O N U P .

Bounded by a circle of 15 miles radius from the centre of Kojonup Townsite.

## N O R T H A M .

Bounded on the *Northward* by a line extending due East from the summit of Mount Pleasant, and by a *Westerly* line from same spot to Viveash's Causeway; thence along the *Southern* boundary of Avon Location X to its South-West corner; then by a due *West* line to the summit of the Darling Range. On the *Southward* by a due *East* line from the North-East corner of Avon Location J; then by a line from same spot *Westward* along the *Northern* boundaries of Locations J and f, and by a due *West* line from the North-West corner of last named Location to the summit of the Darling Range. All bearings true.

In consequence of the foregoing, the boundaries of the undermentioned Districts will be altered as follows:—

## N E W C A S T L E .

Bounded on the *Southward* by the *Northern* boundary of the Northam District, and by the boundaries of the Toodyay Residency, except that portion contained in the Northam District.

## Y O R K .

Bounded on the *Northward* by the Northam District; on the *Southward* by the Beverley District, and by a due *West* line from Boyagarring Hill to the Darling Range.

## A L B A N Y .

All the lands within the Plantagenet Residency, except that portion contained in the Kojonup District.
