TWENTY-FIFTH NOTICE.

S.O.L.—AVON (*Watts'*).

Bounded by lines starting from the South-west corner of Tillage Lease 7088, and extending West 7 chains to a Public Road, and North-west corner of S.O.L. 136, and North along the West boundary of said Tillage Lease 7088, 25 chains; then East 40 chains, South 9 chains, East 13 chains, North 30 chains 50 links; then West about 85 chains to road; then by the North-east side of road to the North-west corner of S.O.L. 136. All bearings true. Content—100 acres.

S.O.L.—AVON (*Brown's*).
