BAY OF BENGAL—COROMANDEL COAST—
MADRAS.

PROHIBITED ANCHORAGE NEAR THE BRITISH
INDIAN SUBMARINE TELEGRAPH CABLE.

The Madras Government has given notice, with a view to the prevention of damage to the British Indian Submarine Telegraph Cable, and under the provisions of the "Indian Conservancy Act," that all vessels are *strictly prohibited* from anchoring in any part of the Madras Roadstead to the southward of the lighthouse. Vessels arriving from the Colonies with horses should anchor in not less than 7 fathoms water, with the lighthouse bearing from West to W. by S., and nothing to the southward of the former bearing. Commanders infringing these directions will be *prosecuted* under the provisions of Act XII of 1875.
