TENDERS (in duplicate, endorsed "Tender for [as the case may be] Mail,") will be received at this Office until noon of Wednesday, 17th November, 1880, for the conveyance of the undermentioned Mails for one, two, or three years, viz. :—

1. From Fremantle to Rockingham, and *vice versa*, once a week, on horseback.
2. From York to Newcastle, *via* Northam, and *vice versa*, once a week, in a four wheeled spring vehicle.
3. From York to Beverley, in a spring vehicle, twice a week, and from Beverley to Brookton, Moorumbine, Boyadine, and Annandale, once a week, on horseback.
4. From York to Beverley, in a spring vehicle, twice a week, and from Beverley to Moorumbine, *via* Brookton, returning *via* Walwalline and Boyadine to Beverley, once a week, on horseback.
5. From Kojonup to Etipup, twice in every four weeks, and *vice versa*, on horseback.

The arrival and departure of the Mails will be subject to instructions from the Postmaster General, and liable to alterations at any time during the year.

Two approved sureties will be required to join the Contractor in a guarantee for the due fulfilment of the duties contracted to be performed.

Special Forms of Tender, with conditions attached, may be had on application to the various Resident Magistrates, and at the General Post Office, Perth; and no Tender will be entertained unless rendered on the prescribed form.

The Government will reserve to themselves the right to terminate the Contract at any time by giving three months' notice.

When Mails are conveyed in wheeled vehicles, a free passage must be provided for an Officer of the Post Office or Telegraph Department, when required by the Postmaster General.

The Government do not bind themselves to accept the lowest or any Tender.

THE following By-laws, compiled and passed by the Northam Municipal Council, have been confirmed by His Excellency the Governor, with the advice of the Executive Council.

Northam Municipality, By-Laws.

WHEREAS by "The Municipal Institutions Act, 1876," section 49, it is enacted that "it shall be lawful for the Council to make, publish, alter, modify, amend, or repeal such By-Laws and Regulations as to them shall seem meet for regulating their own proceedings," and for certain other purposes in the said section particularly mentioned; and by the said Act it is further enacted that "such By-Laws should not be inconsistent with, or repugnant to, any of the provisions of that Act or to any Law in force, and when confirmed by the Governor, with the advice of the Executive Council, and published in the *Government*

Gazette, but not sooner or otherwise, should have the force of Law:” Now therefore, pursuant to the powers contained in the said Act, it is ordered and directed by the Council of the town of Northam that the following By-Laws shall, from and after confirmation and publication as aforesaid, be By-Laws of the said Northam Town Council:—

ORDER OF PROCEEDING.

1. The Council shall meet at the Hall of the Mechanics’ Institute on the second Thursday in every month, or oftener if necessary, at the hour of 8 o’clock p.m., for the transaction of their ordinary business.

2. The Council shall commence business so soon after the above-named hour as there is a sufficient number of members in attendance to constitute a quorum; but if at the expiration of one-half hour from the above-mentioned hour there is not a quorum present, the Council may adjourn.

3. That if at the expiration of the said one-half hour from the said hour of eight o’clock p.m., the Chairman should not be present, the Council shall, if a quorum be present, proceed to elect a Chairman from the Councillors present, who shall act as such during the absence of the Chairman of the Council.

4. At all meetings of the Council, when there is not a quorum present, or when the Council is counted out (which counting out shall take place whenever there shall be less than one-third of the members of the Council present exclusive of the Chairman or Councillor chosen to preside in his absence), such circumstance, together with the names of the members present, shall be recorded in the Minute Book.

5. At all meetings of the Council, the minutes of any preceding meeting, not previously confirmed, shall be read as the first business of the meeting in order to their confirmation; and no discussion shall be permitted thereupon, except as to their accuracy as a record of the proceedings.

6. Immediately after confirmation of the minutes, the Chairman may make any communication to the Council which he may deem advisable, or bring under consideration any business he may think necessary, and then the ordinary business shall be proceeded with.

7. No By-Law shall be finally passed or adopted at the meeting at which it shall have been first proposed, nor until the next ordinary meeting of the Council; and every such By-Law shall, in the interim, remain open for the inspection of any of the Ratepayers, at the office of the Council.

THE COLLECTOR, HIS POWERS AND DUTIES.

8. The Collector for the time being duly appointed by the Council shall demand, collect, and receive all rates, assessments, license fees, fines, forfeitures, rents, tolls, and other sums due to the Council, and his receipt shall be a full and sufficient discharge for any sums paid to him; and all sums so received by the collector shall be by him paid to the Treasurer of the Council monthly.

THE CLERK TO THE COUNCIL.

9. The Clerk to the Council shall keep the books of the Council, and shall duly keep, and enter in a proper minute book, minutes of all proceedings of the Council. He shall attend all meetings of the Council, issue notices of all

meetings, and shall prepare for the Council or Chairman thereof, and in due time, the Voters’ Lists for the Municipality, and for the Wards thereof, and cause them to be affixed as by the said Act required, and shall supply copies thereof as by the said Act required; and shall make up and complete, under the direction of the Council, the Rate Book; and shall, under the like direction, prepare the annual estimates as by the said Act required. He shall also keep all such books of account as are required to be kept by the 124th section of the said Act. He shall also, under the like direction of the Council, cause the accounts of the Council to be balanced half-yearly, as required by the said Act. He shall also, under the direction of the Council, prepare the Annual Financial statement or summary; and shall do and perform all such other acts as the Council or Chairman thereof may lawfully require him to do under or by virtue of the said Act; and shall attend the Council office during such hours as the Council may determine.

10. The Treasurer shall have the custody of the Common Seal, and of all deeds and records of the Council; but he shall not affix the Common Seal to any Corporate document without the express order of the Council.

11. The Treasurer shall receive monthly from the Collector all sums stated to be received by him under By-Law No. 8 and give the Collector a receipt for such moneys, and all sums so received by the Treasurer shall be by him paid into the Bank to the credit of the Council.

12. The Treasurer shall (if required by the Council at any time so to do) give a bond with two sureties, in a sum to be named by the Council, conditioned for the fair and diligent discharge of his duties.

13. The Treasurer shall, out of the moneys received by him as Treasurer of the Council, pay all accounts duly and lawfully passed by the Council at its ordinary monthly meetings, and shall make all other payments which the Council may lawfully pass and order for payment. All accounts above twenty shillings to be paid by cheque drawn by the Treasurer and countersigned by the Chairman.

14. The Inspector of Nuisances, for the time being duly appointed by the Council, shall carry out the Sanitary Regulations in part 6 of “The Municipal Institutions Act, 1876.”

WEIGHTS AND MEASURES.

15. The Inspector of Weights and Measures has, by order of the Council, under its Common Seal, been appointed keeper and examiner of all weights, balances, and measures, within the jurisdiction of the Council; and the standard weights and measures are deposited with him, and the said Inspector shall demand and receive, by virtue of the Ordinance 3 William IV, No. 2, Sec. 2, a fee of sixpence for each and every weight and measure compared.

16. That any person who shall obstruct or resist any officer appointed by the Council, in the discharge of his duty shall, independent of any penalty which he or she may otherwise incur, forfeit and pay any sum not exceeding Forty shillings.

17. That the occupier of any premises within the town whereof any chimney-flues shall take fire from having been suffered to become foul shall forfeit and pay, upon conviction, a penalty not exceeding Forty shillings.

18. Any person or persons who shall, without first having obtained the written sanction of the Council, break up, cut down, damage, destroy, or injure any footpath, tree, plant, fence, gate, water course, culvert, bridge, or other property belonging to or in charge of the Council, shall forfeit and pay for every such offence any sum not exceeding Twenty pounds.

19. The Council may authorise any person to keep and depasture cattle, horses, swine, sheep, or goats, within the limits of the Municipality for such period and on such terms and conditions as they may think fit.

20. The following license fees shall be charged for the time being in the Northam Municipality, and taken by the Collector.

21. Any person who shall knowingly or carelessly suffer any unlicensed horse, mare, gelding, foal, bull, ox, cow, heifer, calf, pony, mule, ass, swine, sheep, or goat, belonging to him or in his apparent ownership or in his charge to be tethered or to depasture, feed, or roam about whether attended by a keeper or not in or upon any street or public thoroughfare forming a portion of the Municipality, shall on conviction forfeit and pay for every such offence, in lieu of the penalty imposed by the 3rd sec. of the 39th Vict. No. 19, the following fines agreeably to the provisions of the aforesaid sections of the said Act.

22. That the Public Pound for the Municipality shall be the new Pound erected on Northam Town Lot, No. 196, in Wellington Street.

23. It shall not be lawful for any person or persons to build or have a hay, corn, or straw stack, nearer than twenty yards to any building which belongs to his neighbour within the Municipality, and any person offending against this By-Law shall forfeit and pay any sum not exceeding Forty shillings.

24. No person or persons shall quarry or remove stone, gravel, or sand, on or from any lands under the control or charge of the Council, without permission from the Chairman, and shall pay the fee of three pence per load for every load of stone, gravel, or sand, removed from or off said lands, to the Collector of the Council, and any breach of this By-Law shall render the offender liable to a penalty not exceeding Forty shillings.

25. Any person wishing to cut firewood or timber on any lands belonging to or in charge of the Council shall pay a fee of Five shillings per month for one man, and Ten shillings per month for two men; and any offender against this By-Law shall, upon conviction, forfeit and pay any sum not exceeding Forty shillings, and any timber so cut to be forfeited.

26. It shall not be lawful for any person or persons to erect or have a pigsty or privy nearer than ten yards to any public street or thoroughfare within the limits of the Municipality.

The above By-Laws were re-considered by the Council at a special meeting, on Monday, 24th May, 1880, and revised in accordance with remarks thereon by the Honorable the Acting Attorney General.
