Wales and its Dependencies.

WHEREAS by section ten of an Act of the Parliament of New South Wales passed in the thirty-fifth year of the reign of Her present Majesty, intituled "The Imported Stock Act of 1871," and numbered six, the Governor in Council is empowered by proclamation in the Government Gazette to restrict or absolutely prohibit for any specified time the importation or introduction of any horned cattle or sheep, fodder, or fittings from any other Colony or country in which there is reason to believe that any infectious or contagious disease in stock exists: And whereas by proclamation, dated the fourth day of July, 1878, it was declared that cattle and sheep might be imported or introduced from Great Britain, Ireland, Canada, and the United States of America under certain conditions and regulations therein set forth: And whereas foot and mouth disease is known to be prevalent in Great Britain: Now, therefore, I, Lord AUGUSTUS WILLIAM FREDERICK SPENCER LOFTUS, the Governor aforesaid, with the advice of the Executive Council, do, except as regards horned cattle or sheep which shall have been shipped from London previous to the notification in the London Gazette of the issue of this Proclamation, hereby revoke all former proclamations under the abovenamed Act, and

absolutely prohibit for a period of two years from this date the importation of all horned cattle or sheep, fodder, or fittings, from any Colony or country other than the colonies of Victoria, South Australia, Queensland, Western Australia, Tasmania, and New Zealand.

Given under my Hand and Seal, at Government House, Sydney, this eleventh day of January, in the year of our Lord one thousand eight hundred and eighty-two, and in the forty-fifth year of Her Majesty's Reign.
