NEW ZEALAND.

SHOAL IN FOVEAUX STRAIT.

Information has been received from the Marine Department, Wellington, New Zealand, that a shoal has been discovered about 4 miles eastward of Ruapuke island, eastern entrance of Foveaux strait.

This shoal (*Fairchild shoal*) has over it a depth of 4 fathoms, rocky bottom, with from 7 to 12 fathoms around, and lies with the following bearings:—

Green island, east extreme ... S.W. by S., distant	4½ miles.
Toby rock (awash) ... S.W. ¾ W., "	2 "
Dog island lighthouse ... W. ½ N., "	11½ "

NOTE.—The breakers formerly charted at 2 miles N.N.E. ½ E. from Toby rock, are considered not to exist, and have been expunged from the Admiralty charts.

(The bearings are Magnetic. Variation 17° Easterly in 1882.)

10. From Baunister to Marradong, and *vice versa*, once a fortnight, on horseback.
11. From Perth to Wanneroo, and *vice versa*, once a week, on horseback.
12. From Bunbury to Balbarrup, *via* Dardanup and Bridgetown, and *vice versa*, once a week, on horseback.
13. To convey mails, deliver letters, &c., between Guildford and Chittering, and *vice versa*, once every four weeks, and between Guildford and Swan, and *vice versa*, once a week, on horseback.

The arrival and departure of the Mails will be subject to instructions from the Postmaster General, and liable to alteration at any time during the year.

Two approved sureties will be required to join the Contractor in a guarantee for the due fulfilment of the duties contracted to be performed.

Special Forms of Tender, with conditions attached, may be had on application to the various Postmasters, and at the General Post Office, Perth; and no Tender will be entertained unless rendered on the prescribed form.

The Government will reserve to themselves the right to terminate the Contract at any time by giving three months' notice.

Where Mails are conveyed in wheeled vehicles, a free passage must be provided for an Officer of the Post Office or Telegraph Department, when required by the Postmaster General.
