The Fishery Act, 1889.*Colonial Secretary's Office,
Perth, 17th November, 1892.* $\frac{1892}{92}$

WHEREAS in pursuance of the power vested in the Governor in Council by "The Fishery Act, 1889," the Governor in Council did, by Regulation published in the *Government Gazette* on the 9th June, 1892, declare it unlawful for any person to fish, by means of any net or fixed engine, within the following limits of the Canning River, that is to say:—

From the Lower Canning Bridge to the Upper Canning Bridge,

His Excellency the Governor in Executive Council doth hereby declare and prescribe that such Regulation aforesaid shall not, from the 1st day of December to the 30th day of April in any year, apply to the taking of Shrimps or Prawns, within the following limits of the Canning River, that is to say:—

Between the Lower Canning Bridge and a due East line from Mount Henry across the River.

WHEREAS by Section 6 of "The Fishery Act, 1889," it is enacted that it shall be lawful for the Governor in Council, from time to time, by Regulations to be published in the *Government Gazette*, amongst other things, "to prescribe the limits in or about the "mouth of, or within any river, creek, stream, "estuary, or other inlet of the sea, within which it "shall not be lawful for any person to fish by means "of any net or fixed engine, and to impose such "reasonable penalties, not exceeding £20, and "forfeitures, as the Governor in Council may think "fit, for any breach of such Regulations:—"

His Excellency the Governor in Council does by this Regulation declare it to be unlawful for any person to fish by means of any net or fixed engine in or about the mouth of the Swan River, that is to say:—

Between the Bar and the North Fremantle Road Bridge and a quarter of a mile from the Bar seaward, from the 1st day of December to the 1st day of March in every year.

Every person committing a breach of this Regulation shall be liable, on conviction, to a penalty of £10 for the first offence, and £20 for every subsequent offence, and shall forfeit the net or engine used, and all fish which he shall have taken.

In consequence of the numerous instances which occur of neglect to register Births and Deaths, in accordance with the provisions of the 19th Vict., No. 12, it has become necessary to give notice that from henceforth any person or persons offending against the provisions of the Ordinance will be prosecuted as the law directs, and District Registrars are herewith instructed to institute proceedings against all offenders.

And every District Registrar shall inform himself carefully of every Birth, Death, or Marriage happening within his district, and shall, as soon as possible after the event, register the same respectively.

Section 22.

That in each case of the BIRTH of every child in the said Colony the parent shall, within thirty days, and in the case of the DEATH of any person the tenant of the house or place shall, within fourteen days next thereafter, respectively inform the District Registrar of such Birth or Death, and of all the particulars concerning the same, according to the form of registration hereinbefore referred to.

Section 26.

That in case any new-born child, or any dead body, shall be found exposed, the constable, in case of a new-born child, and the coroner, or, if none such, the Resident or Police Magistrate of the district, in case of a dead body, shall forthwith inform the District Registrar thereof, and of the place where the child or dead body was found; and where an inquest or magisterial inquiry shall be held on any dead body, the coroner or magistrate, as the case may be, shall notify to the District Registrar the verdict of the jury, or the opinion of such magistrate, with all other particulars required to be registered, concerning the death; and such District Registrar shall make the entry accordingly.

Section 30.

That every person who shall offend against this Ordinance by refusing or neglecting to give any notice or information required by any of the foregoing sections, or by knowingly registering any Birth or Death contrary to the provisions of any of the said sections, shall for every
