Establishing Warden's Court at Norseman.

1012 96 PROCLAMATION

By His Excellency Lieut.-Colonel Sir GERARD SMITH, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Colony of Western Australia and its Dependencies, &c., &c., &c.

WHEREAS under the provisions of the 49th Section of "The Goldfields Act, 1895," it is lawful for the Governor, by Proclamation in the *Government Gazette*, to establish on any Goldfield one or more Courts, to be presided over and holden by a Warden, and to be called a Warden's Court, and which shall be a Court of Record, and shall possess such jurisdiction as is conferred by Part IV. of the said Act: AND WHEREAS it is deemed expedient that a Warden's Court shall be established at Norseman, Dundas Goldfield: Now THEREFORE I, Lieut.-Colonel Sir GERARD SMITH, K.C.M.G., Governor as aforesaid, in exercise of the powers so vested in me, and of all other powers enabling me in that behalf, with the advice of the Executive Council, do hereby establish a Warden's Court at Norseman, on the Dundas Goldfield, such Court to be presided over and holden by the Resident Warden of the said Goldfield, or in his absence by the Acting Warden thereof.

Municipality of Esperance.

By-LAW No. 1.—*For regulating the Duties of Officers of the Corporation.*

TOWN CLERK.

This officer is the medium of communication between all the officers of the Corporation and the Council. All officers must, therefore, take their instructions from the Town Clerk.

TOWN CLERK'S DEPARTMENT.

Duties of Town Clerk.

1. To attend all Council meetings.
2. To attend all committees.
3. To take notes of all minutes and prepare reports of committees.
4. Conduct all correspondence, and give the other officers instructions, as directed by the minutes.
5. To answer all questions on Corporation business.
6. See that the accounts are audited twice a year, and the balance sheets prepared and printed yearly.
7. See to the gazetting and printing of all By-laws and advertisements.
8. Also, the assessment books and the citizens' roll, examine proofs of latter, and arrange for distribution of copies prior to the elections; also, attend all courts of revision or appeal, making the necessary arrangements for the elections, and preparing papers, etc., for the clerks.
9. Summoning the members to Council and committees.
10. Prepare all bonds of officers, see that guarantees are given, and agreements for letting Corporation premises prepared, and report to the Council.
11. Prepare and sign all notices and orders for making private streets, fencing in of lands, and repayment of moneys.
12. Advise with the officers from time to time as to their duties and the mode of carrying them out.
13. And fulfil such other duties as may be required by the Council.

OFFICER OF HEALTH.

1. It is the duty of the officer of health to superintend the application of all sanitary measures ordered by the Local Board, and to advise them generally in all such matters.
2. The officer of health shall make frequent examination of the district under his control, and see that the duties of the inspectors are efficiently performed, and report any neglect of those officers, and, if necessary, suspend any of them until such report and neglect has been considered by the Local Board.
3. He is, pursuant to the powers contained in "The Public Health Act, 1896," to inspect premises that may be reported to him, or that he may have reason to believe are in a filthy or unwholesome condition and affecting health, and, if found so, to give a certificate in accordance with section 60 of the Act. He is also required to examine premises where any process of manufacture causing effluvia is carried on, and, if necessary, furnish the Local Board with the required certificate, in accordance with Section 57. He is also to inspect and furnish a certificate, if necessary, of any houses built for habitation, or of any overcrowding, in accordance with Sections 66 and 67. He is also to assist the Board with his presence and advice, if necessary, in order to the carrying out of Section 31, referring to the sale of unwholesome food; and on all occasions to give them the benefit of his medical experience and skill.
4. The officer of health is to report to the Local Board, with the least possible delay, any undue prevalence of disease in his district, whether generally or locally, and in the latter case it will be his duty to attract the attention of the Local Board to the locality in order that remedial measures may be at once taken. He is also carefully to note the appearance in his district of any epidemic, endemic, or contagious disease, or any indications thereof, or any occurrence or circumstances affecting or likely to

involve public health, and he shall immediately make a full report thereof to the Local Board, whose duty it will be immediately to forward his report to the Central Board, in accordance with Section 35; and the health officer is expected energetically to assist in carrying out and enforcing the regulations of the Central Board for mitigating, as far as possible, and preventing and checking the spread of epidemic and other diseases, as detailed in Section 38.

5. The officer of health is to furnish the Local Board of his district, during the months of January and July of each year, with a report on the health, cleanliness, and general sanitary state of his district for that period, making any remarks and observations he may think proper.

6. The officer of health shall, from time to time, issue to the inspector such orders and instructions as the said health officer may deem necessary; and the inspector, being placed under the control of the health officer, is required to report to him direct upon all matters or things appertaining to their respective duties and districts. Any special matter contained in any such reports necessary to be brought under the notice of the Local Board shall be forwarded by the health officer to the Local Board in the usual manner.

7. The officer of health shall obey the orders of the Council.

TREASURER.

1. To keep the cash-book, journal, and ledger, as well as any and all other books required to show the receipts and expenditure made by the Corporation; the said books to be kept written up every month ready for the inspection of the Finance Committee, or any member of the Council who may at any time, during office hours, desire to see them.

2. To check all accounts sent in by the Corporation officers and to see that all accounts for works (exceeding £5 in amount) have stated on them the authority under which such works have been done; to check all returns made by the collectors or others of the Corporation officers, and to see that, with all returns made, the heels of the receipt books accompany the returns, to keep the officers of the Corporation, who pay money to the Treasurer to the credit of the Corporation, up to their time in so paying in. To report to the Town Clerk at once, and also to the Finance Committee at their first meeting thereafter, any officer neglecting to make his returns, as provided, with the necessary vouchers attached thereto.

3. To pay into the bank within forty-eight hours after receipt, to the credit of the Corporation, any sum or sums of money that may be received by him (amounting in the aggregate to £10 or upwards) on behalf of the Corporation, and forward the necessary vouchers to the Finance Committee, and all receipts given by him for moneys received must be signed as Treasurer.

4. To see that all papers necessary for the Finance Committee are ready for them at their meeting; and he is empowered to call for and obtain any paper or books relating to the financial affairs of the Corporation.

5. To see the bank pass-book is made up within two hours of the time of meeting of the Finance Committee, and produce it at each meeting of that Committee; or should any member of the Council desire to see it at any time during office hours, he will produce it for his inspection.

6. No moneys are to be paid into the bank by any officer except by or through the Treasurer.

7. Treasurer to give receipt on printed form to the officer, on receipt by him of that officer's cash.

8. All moneys received by the Treasurer to be lodged in the strong-room and carefully secured by him before leaving the office.

9. Treasurer to make weekly or fortnightly returns as heretofore.

10. The Treasurer shall readily and cheerfully obey all lawful commands or orders of the Council transmitted to him through the Town Clerk.

Any other matter relating to the finance of the Corporation not herein specified, he must attend to as though it had been inserted in these instructions.

SURVEYOR'S DEPARTMENT.

Duties of Surveyor.

1. To promptly attend to all instructions received through the Town Clerk in writing.

2. Prepare proper plans and specifications for all works and improvements as regards streets, roads, bridges, buildings, or premises under control of the Council, situate within the bounds of the Town of Esperance, examine all materials to be employed in such works, and see the same

faithfully and properly executed and performed; lay out such work as to height, lines, levels and dimensions, and watch the progress and formation, lest such height, lines, etc., etc., should be altered; measure all metal before being used on any works, and measure and make returns to Finance Committee for payment for all works and material; submit all specifications and plans to the Public Works Committee before advertising.

3. See that the work of cleansing and repairing all public streets, roads, and footways is properly carried out.

4. See that the work of scavenging and removal of rubbish from all tenements within the town is properly carried out.

5. See that no labourers are engaged, or if engaged, are retained in the service of the Corporation, but those who are able-bodied and sober, and the surveyor is to immediately discharge any labourer guilty of disobedience, insubordination, or found incapable of performing the duties allotted to him.

6. See that the time of the men is returned by the gangers, and, if satisfied of the correctness thereof, the pay-sheets made out accordingly.

7. Give the necessary lines and levels to persons building next to public ways, and see that there is no encroachment on public property.

8. See that all sewers, drains, culverts, and bridges are maintained in a state of efficiency.

9. See that the laws with regard to buildings within the Town are not infringed; to take action in the case of "dangerous buildings." See that the requirements of the Public Health Act are strictly carried out; also all Acts and By-laws coming within the control of the department.

10. See that all the officers under his control carry out their duties efficiently, and to report any departure therefrom.

11. To attend meetings of Committees if required.

12. To render to the Town Clerk, when required, reports and accounts of all matters coming under his control. To supply fortnightly to the Council returns of work completed or in progress, with remarks thereon.

13. To define, from time to time, the duties of the gangers, and see that they are communicated to them in writing.

GENERAL INSTRUCTIONS TO OFFICERS.

1. At all times officers of the Corporation, in passing through the town, are required to be watchful and vigilant, and report immediately to the Town Clerk any dereliction of duty on the part of the contractors, or any infringement of the Corporation Acts or the town By-laws.

2. Any officer must, on the direction of the Town Clerk, assist (for the time being) any other officer of the Corporation as instructed.

3. No officer is to be absent without leave. Special leave may be obtained, to the extent of one day only, from the Town Clerk, if he is satisfied as to the urgency of the occasion.

4. Should any officer be absent from illness, he must notify the same to the Town Clerk; and if ill for more than twenty-four hours, such notification shall be accompanied by a medical certificate.

BY-LAW No. 2.—*For providing and maintaining suitable closets and urinals, and for prohibiting cesspits.*

1. The owner of every house or premises within the Town of Esperance shall cause to be constructed on said premises a suitable closet, provided with the pans adopted by this Council. Such closet shall be maintained and ventilated to the satisfaction of the officers of the Council with a proper outlet at side or back of closet for removal of cesspan, proper door for same being hung on side, and shall in no case be situated at a less distance than twenty feet from any dwelling-house or place of business, except by the express permission of the Council first obtained.

2. The receptacle of every closet shall be constructed of galvanised iron; it shall be water-tight, and the ground floor of the closet upon which it stands shall be cemented or otherwise made impervious, and the receptacle shall be emptied once a week.

3. No urinal with cess-pool attached shall hereafter be constructed in the said Municipality unless the urinal is built in a substantial and suitable manner for the use required thereof, and unless the walls of the cess-pool, 6in. below the level surface of the ground around it, be built of stone or concrete of the thickness, as respects stonework, of 12in., and concrete, of 9in., and of the following dimensions, viz., 4ft. long, 3ft. wide, 4ft. deep, and so constructed and cemented and made water-tight. All drains connecting the urinal with cess-pool to be constructed so as to be water-

tight. Cess-pool to be covered with a strong wood top, over which a layer of earth must be placed to prevent the effluvia arising therefrom. All cess-pools must be emptied of their contents when notice to that effect has been duly served upon the owner or occupier of the premises; and no urinal and cess-pool erected after the date of this regulation coming into operation shall, unless constructed as hereinbefore is provided, be suffered to remain after six days' notice, in writing, from any officer of the Municipality to remove or fill up same.

4. Every person who shall commit a breach of this By-law shall be liable to a penalty not exceeding £10 nor less than 5s., and to a further penalty not exceeding £5 nor less than 5s. for each day during which such breach or omission shall be committed or continued.

BY-LAW No. 3.—*For preventing the placing of any offensive liquid or any refuse matter on streets or lanes, etc.*

1. No foul or offensive water or other liquid, and no garbage, sweepings, or any other refuse, matter, or thing shall be pumped, emptied, swept, thrown, or otherwise discharged into or upon any part whatever of any street or lane, whether public or private, within the limits of the Town of Esperance.

2. No garbage, sweepings, or other refuse shall be scattered, heaped, or deposited within any yard or premises within the town, save in boxes or vessels which, when filled, may be reasonably carted by one man, and which shall be specially provided by the occupier of the house or building to which such yard is attached, and shall be so placed and kept as to be readily accessible to the person employed by the Council for removing the same.

3. For every offence against the provisions of this By-law the offender shall be liable to a penalty not exceeding £10, and not less than 5s.

BY-LAW No. 4.—*For preventing obstructions to Streets, Footways, or Waterchannels, and other matters.*

Any person who shall make, or cause to be made, any hole or excavation in any street, lane, or public place, or who shall encumber or obstruct any street, footway, or watercourse within the Town of Esperance, by placing thereon or therein any article or material whatsoever, without having previously obtained a written permit from the Council so to do, or having obtained such permit shall neglect to remove such article or material when ordered by the Council so to do, shall be liable to a penalty not exceeding £10.

BY-LAW No. 5.—*For the punishment of any Contractor or other person who shall deposit, or cause to be deposited, any Rubbish or Materials on the surface of any Street or Roadway in the Town of Esperance, and other matters.*

1. Any person who shall place, lay, deposit, shoot, or discharge any rubbish or materials whatsoever on the surface of any street or roadway or public reserve within the Town without having first obtained from the Council a permit so to do, shall forfeit and pay, for each offence, a sum not exceeding £10.

2. Every person shall, after having received from the Council, as in the next preceding section provided, a permit to deposit rubbish or materials on the surface of any street, have and keep a sufficient and continuous light burning thereon from sunset to sunrise during the time such rubbish or material shall remain and continue so deposited.

3. Where any building materials, rubbish or other things shall be laid, or any hole or excavation shall be made, in any street or lane within the Town, the person depositing or causing such materials or other things to be so laid, or the said hole or excavation to be made, shall, at his own expense, cause a sufficient light to be fixed in a proper place upon or near the same, and continue such light every night from sunset to sunrise during the time such materials, hole, or excavation shall remain; and such person shall, at his own expense, cause such materials, rubbish, or other things, hole, or excavation, to be sufficiently fenced and enclosed until such materials and other things shall be removed, and the hole or excavation filled up or otherwise made secure; and in case such person shall refuse or neglect so to light, fence, or enclose such materials or other things, or such hole or excavation, he shall for every such offence forfeit and pay a sum not exceeding £10.

BY-LAW No. 6.—*To prevent obstructions to the Footpaths of the Streets within the Town of Esperance.*

Every tradesman, merchant, or other owner who shall permit any goods, wares, merchandise, boxes, cases, coal, firewood, or other articles to remain or be on any footway, or any portion thereof, of any street in the town for a longer period than shall be necessary for housing or removing the same, shall forfeit and pay for every such offence a penalty not exceeding £5.

BY-LAW No. 7.—*For preventing Broken Bottles, Earthenware, etc., being thrown on the Streets, or Beach, or Public Reserves of the Town of Esperance.*

Any person or persons placing or having placed, or causing or having caused to be placed or broken, in or upon any road, pathway, reserve, or park lands under the control or supervision of the Town Council, any glass, metal, or earthenware, bottles, or utensils, without having first obtained the consent of the said Council so to do, shall be liable, beyond the cost and charges incidental to the removal of any such glass, metal, or earthenware, to a fine, upon conviction, not exceeding £10, in addition to amount of damage caused thereby.

BY-LAW No. 8.—*For preventing Animals or Vehicles being left in the Street, or obstructing any portion of any Street.*

No person shall leave any horse, ass, mule, camel, ox, cow, or goat, or any vehicle to which there may or may not be attached and harnessed any animal, unattended in any street, or at any place of public resort or entertainment, and any Corporation officer or police constable may seize and remove any such animal or vehicle to the nearest public pound, police pound, or town hall yard, and the person so leaving such animal or vehicle shall forfeit and pay a sum not exceeding £2, in addition to any pound fees which may have become due and payable by reason of such impounding.

BY-LAW No. 9.—*To restrict the Breaking-in of Horses or other Animals in the Streets of Esperance.*

No person shall break in any horse, mare, gelding, pony, mule, ass, or camel in any street or thoroughfare of the town of Esperance, either by leading, riding, or driving the same.

BY-LAW No. 10.—*Regulating Signboards.*

1. No person shall place or suspend in any street or lane in the Municipality of Esperance any signboard or other sign, showbill, or showboard, which shall project more than three feet from the building line, or be at a lesser height than eight feet in the clear from the ground except by permission of the Council.

2. Every person offending against this By-law shall be liable to a penalty not exceeding £5.

BY-LAW No. 11.—*Prohibiting Fires in the open air.*

1. Every person who shall place or permit to be placed in any street, lane, yard, or place, whether public or private, any fire or combustible material of any kind in such manner as to endanger any contiguous building, shall be liable to a penalty of not less than 5s. nor more than £5 for such offence, and shall be further liable to a similar penalty for every day during which said offence shall be continued.

2. Any unprotected fire in the open air made or permitted within ten yards of any dwelling-house, store, or other building, or within five yards of any fence shall, for the purposes of this By-law, be held to endanger such building or other structure.

BY-LAW No. 12.—*Prohibiting slaughtering of certain animals, and regulating sale of meat.*

1. It shall not be lawful for any person to slaughter cattle or sheep within the limits of the Municipality of Esperance, save and except for the sole use of himself and his family.

2. No person shall bring or cause to be brought or carried through any street or lane in any cart or other vehicle any butcher's meat or carcass of meat for food unless such meat shall be duly protected from the sun and dust.

3. Every cart or other vehicle and every construction or covering for carrying and protecting meat shall be kept in a clean and healthy state.

4. Every person offending, by neglect or otherwise, against the provisions of this By-law shall be liable to a fine of not less than £1 nor more than £5 for every such offence.

BY-LAW No. 13.—*Prohibiting the keeping of pigs.*

1. It shall not be lawful for any person to keep (*vide* subsec. 28, s. 99, Municipality Act) swine within the Municipality of Esperance.

2. Any person who shall offend against the provisions of this By-law shall be liable to a penalty of not less than £1 nor more than £5.

3. Nothing in this By-law shall apply to any swine brought into the town for sale and removed therefrom within twenty-four hours.

BY-LAW No. 14.—*Encroachments or obstructions to be removed.*

1. On the order of the Council, the Town Clerk or other appointed officer may direct the removal within fourteen days of any building, fence, or other obstruction or encroachment in or upon any street, lane, or public place under control of the Council.

2. In any case where, after service of notice for such removal, any such encroachment or obstruction has not been removed within the specified time, it shall be lawful for the officer appointed by the Council to remove the same, at the cost and charges of the person so offending, and to proceed against the offender for the breach of this By-law, the penalty for which breach shall not be less than £1 nor more than £25 for every day or part of a day during which such offence shall be committed or continued after the expiry of the notice prescribed herein.

BY-LAW No. 15.—*Construction of Footpaths Crossing Places.*

To regulate the construction of footpath crossings:—

(1.) It shall be lawful for the owner of any land fronting or adjoining any street or public way, requiring access thereto with horses and vehicles from such street to such land across any existing made footway, channel, or gutter, having first had and obtained the consent of the Council to construct a crossing of such dimensions and materials, and in such form and manner as the regulations of the Council for the time being require, or as may be directed by the town surveyor, and shall thereafter keep and maintain the same in good and safe repair.

Any person not complying with the provisions of this By-law shall, upon conviction, forfeit and pay a sum not exceeding £5.

(2.) Every person who wilfully, and without lawful excuse, shall ride or drive or wheel any carriage, cart, or other vehicle, or shall ride any bicycle, velocipede, or tricycle upon, along, or across any footway or water channel or gutter by the side of any street, road, or public way, save in each such case upon and by or at some properly constructed crossing, shall forfeit and pay, upon conviction, a sum not exceeding £5, and shall also pay to the Council such sum, not exceeding £10, by way of compensation for any damage done to the footpath or channel, as the justice adjudicating upon the information shall on the hearing thereof order.

BY-LAW No. 16.—*Driving around corners, etc.*

Every person who shall ride or drive any animal or animals, whether attached to any vehicle or not, at a rate exceeding 6 miles an hour, or at more than a walking pace round the corners formed by the junction of any street in the Municipality, provided always, the Council shall have put up notice boards at or near such street intersections requiring the public to ride or drive round such corner at a walking pace, shall, for every such offence, forfeit and pay, upon conviction, a penalty not exceeding £2.

Every person who shall drive any horse or other animal drawing any waggon, dray, cart, or other such carriage, without springs, at a faster rate than a common walk, through, over, or along any street, road, or thoroughfare in the Municipality shall, on conviction, forfeit and pay a penalty not exceeding 40s.

BY-LAW No. 17.—*To enforce Lights on Vehicles, etc., at Night.*

Any person who, between any sunset and the following sunrise, shall, in, upon, or along any of the roads or streets within the Municipality, ride any bicycle, tricycle, or velocipede, or drive any vehicle constructed for the conveyance of goods, wares, or merchandise, without having a lamp or lantern securely fixed and kept lighted at the off side of the front of such vehicle, or any vehicle constructed for the conveyance of persons as well as goods, wares, and merchandise, or of persons only without a lamp or lantern securely fixed and kept lighted on each side of the front of such vehicle, shall, for every such offence, forfeit and pay, upon conviction, a penalty not exceeding £5.

BY-LAW No. 18.—*Roof Gutters, Down Pipes, and Drains.*

The owner or occupier of every house, shop, verandah, balcony, or other building, in, adjoining, or near to any street or public way, shall, within seven days next after service of a notice by the Council for that purpose, put up a sufficient shoot or gutter to the whole length of such house, shop, verandah, balcony, or other building, and shall connect the same with suitable down-piping, fixed to the front or side of such building, from the roof to the ground in such manner, that the water from such buildings shall not fall upon persons passing along the street or public way, or flow over the footpath or roadway, but shall be conducted

under the footpath by means of a pipe, of such material and in such manner as shall be directed by the Council or the Town Surveyor, and shall be at sufficient depth as to cause no obstruction to persons passing over, and shall be connected with the gutter or channels, at edge of footpath or roadway; and in default of compliance with such notice within the period aforesaid, or with the provisions of this section, such owner or occupier shall forfeit and pay a sum not exceeding £10.

By-Law No. 19.—*To prevent Damage to Footpaths and other Council Property.*

Any person who shall (without first having obtained the written sanction of the Council) break up, cut down, damage, destroy, or injure any footpath, drain, gutter, culvert, bridge, road, public way, tree, plant, gate, fence, post, lanthorn, implements, material, building, or other property belonging to, or in the possession of the Council, shall forfeit and pay, upon conviction, for every such offence, a sum not exceeding £10.

By-Law No. 20.—*To prevent Chimneys taking Fire.*

The occupier of any premises within the Municipality whereof any chimney flue or flues shall take fire from having been suffered to become foul shall forfeit and pay, upon conviction, a penalty not exceeding £5: Provided if any defendant shall plead that such flue did not take fire in consequence of being foul, the proof shall lie with such defendant.

By-Law No. 21.—*Public Stands for Licensed Vehicles.*

The places set forth and described in an advertisement, published by the authority of the Municipal Council, "as public stands" for vehicles that are licensed to carry passengers or merchandise shall be and are public stands, where all such licensed vehicles shall ply for hire, and such public stands, or such other stands in such other places as the Council may from time to time appoint (due notice of which shall be given by public advertisement either in the *Government Gazette* or in one of the local papers), shall be and continue to be public stands for vehicles only that are licensed to carry passengers or merchandise until abolished by the Council. And every owner, driver, or person in charge of such vehicle licensed as aforesaid, who shall, after such notice, draw up or station such vehicle at any other place, in order to ply for hire, shall be deemed to have committed a breach of this By-law and, upon conviction, shall forfeit and pay, for every such offence, a sum not exceeding 40s. nor less than 10s.

By-Law No. 22.—*Verandah height and width measurements.*

That any verandah erected shall extend from the building line of the street to the outer edge of the footpath, and such verandah shall be not less than seven feet in height clear above the street level.

By-Law No. 23.—*To regulate the hours for bathing in the Sea within the Municipal boundaries.*

That no person or persons shall be permitted to bathe in the sea excepting in such place as may be appointed by the Council and defined by notice boards, and then only before the hours of 7 a.m., and after the hour of 7.30 p.m.; any person or persons infringing this By-law shall be subject to a penalty not exceeding £5.

By-Law No. 24.—*For licensing vehicles.*

That any vehicle let on hire or used for the conveyance of passengers or goods shall be licensed and pay a tax of 10s. per pair of wheels per annum, and the owner or driver of any vehicle as described above plying without having first paid the above licensing fee or tax shall be liable to a penalty not exceeding £5 for every breach of this By-law.

By-Law No. 25.—*For licensing Horse Bazaars and Marts.*

That all premises used as a bazaar or repository for the sale of horses, horned cattle, carriages, and other vehicles, or any of them, shall pay a licensing fee of 20s. per annum. Said fee to be paid by the owner or lessee of such premises.

By-Law No. 26.—*To prevent rubbish being deposited on the Beach or in the sea.*

That any person or persons depositing rubbish or offensive matter, solid or liquid, on the beach or in the sea, within the boundaries of the Municipality of Esperance shall be subject to a penalty not exceeding £10.

By-Law No. 27.—*For making Owners or Lessees fence vacant lands.*

That all vacant lands within the boundaries of the Municipality of Esperance shall be fenced wherever abutting on a street or other public thoroughfare, within a period not exceeding 60 days after date of notice so to do has been posted or delivered by Town Clerk, or other Municipal Officer, to owner of such land. Such fence to resist great cattle, but no barbed wire to be used in its construction.

Should any owner of land fail to comply with the foregoing By-law, the Council shall have the right to erect any fence they may deem fit at the cost of such owner.

By-Law No. 28.—*Hawkers' License Fees.*

That all persons hawking fruit, fish, or vegetables shall be licensed, and pay a fee of 10s per annum for such privilege.

By-Law No. 29.—*Hawkers' Carriage and Cart and other Licenses how to be paid.*

All Hawkets' carriage and cart licenses and fees must be paid within fourteen days of notice of same being due appearing in local paper.

By-Law No. 30.—*Stables, Cowsheds, Goatsheds, Pigstys, etc.*

The occupier or owner of any land within the Municipality on which there shall be erected any stable, cowyard, cattle-shed, goatshed, sheep-pen, or pigsty shall cause such premises to be kept in such a state in respect of cleanliness as not to be a nuisance or injurious to health, and shall cause all dung, soil, or other manure produced or accumulated thereon, to be collected in one place on such premises, and shall keep the same until removed or required for use, in an inoffensive condition, and so as not to be productive of any nuisance. All pigstys shall be properly paved or flagged with stone or slate, or otherwise made impervious, and at all times to be kept in a cleanly and inoffensive state.

HIS Excellency the Governor in Executive Council has been pleased to confirm the following By-laws made by the Municipal Council of North Fremantle, under "The Building Act, 1884."

"The Building Act, 1884."

By-Law No. 1.—*License Fees (Secs. 5 and 6).*

1. No person shall erect hoarding or fence, or deposit any materials on the street or pavement, without first obtaining a license from the Town Surveyor. The fees to be paid for such license shall be five shillings per month or any part of a month.

Any person offending against this By-law shall incur a penalty not exceeding £10 for every such offence.

By-Law No. 2.—*Party Walls (Sec. 12).*

2. All partitions between separate houses or other buildings erected or altered in future, whether such houses or other buildings shall belong to one or more owners, shall be of not less than 12in. stone or 9in. brickwork, and shall entirely separate the woodwork of the two roofs; the said party walls shall be carried up at least 9in. above iron roof, and 15in. above shingled roof. Any person neglecting to comply with these provisions shall incur a penalty of not exceeding £20.

By-Law No. 3.—*To regulate the construction of Water Closets, Earth Closets, or Privies (Sec. 19).*

3. Every house or other building shall have attached to it water closets, earth closets, or privies of the following construction: the size above floor to be not less than 4ft. x 5ft., and not less than 6ft. 6in. high on the lowest side; it must also have a stench pipe, at least 3in. in diameter, to lead from the seat through the roof 1ft. 6in. above the same. The walls to be constructed of 4½in. brick work or 12in. stone work, and not to be erected closer than 3ft. from boundary of grant. Cesspits for privies to be constructed of 12in. stone work, or 9in. brick work, with 6in. of concrete on bottom, to be cemented and made thoroughly water-tight, and inspected and passed before being used. Any person violating any of these provisions shall incur a penalty of an amount not exceeding £5.

By-Law No. 4.—*To regulate the size of Ashpits (Sec. 20).*

4. All dwellings erected after the passing of the Act to have ashpits of the following dimensions: for cottages of 3 rooms and under, 3ft. x 2ft. and 4ft. deep; for villas, 4 to 6 rooms, 4ft. x 3ft. and 4ft. deep; for houses, 6 to 10 rooms, 6ft. x 4ft. and 4ft. deep; for houses, 10 to 18 rooms, 8ft. x 5ft. and 4ft. deep.

If such ashpits are not constructed, Council will construct same at the expense of the owner, as provided by the Act.

By-Law No. 5.—*Walls, etc.*

5. Every wall constructed of brick or stone, or other similar substance, shall be properly bonded and solidly put

together with mortar or cement, and no part of such wall (except coping) shall overhang any part underneath it, and all return walls shall be properly bonded together.

BY-LAW No. 6.—*Builder to give notice, etc.*

6. Three days before any building, or any work to, in, or upon any building is commenced, and also if the progress of any such building or work is, after the commencement thereof, suspended for any period exceeding three months, three days before such building or work is resumed, and also if, during the progress of any such building or work, the builder employed thereon is changed, then two days before any new builder enters upon the continuance of such work, it shall be the duty of the builder engaged in the building or re-building of such building, or in continuing such building or work, to give the Town Surveyor notice in writing, stating the situation, area, and height, and intended use of the building or buildings about to be commenced, or to, in, or upon which any work is to be done, and the number of such buildings (if more than one) and also the particulars of any such proposed work, and stating also his own name and address, but any works to, in, or upon the same building that are in progress at the same time may be included in the one notice.

BY-LAW No. 7.—*Surveyor's Fees.*

7. There shall be paid to the Town Surveyor, in respect of his services under this Act, the amount specified in the following schedule, viz.:—

BY-LAW No. 8.

8. The above fees to be paid by the person applying for the license, on delivery of the same, and recoverable summarily before any two Justices of the Peace.

BY-LAW No. 9.—*Town Surveyor to give building line, &c.*

9. That the contractor for any new building about to be erected after this date must apply to the Town Surveyor for the street frontage and levels three days before he enters upon the work, and that the contractor shall have no right to commence such work until he has the said authority in writing from the Town Surveyor, under the penalty of £5 per day for acting contrary to the By-laws, the same to be recoverable under this Act.

BY-LAW No. 10.—*Thickness of Walls.*

10. That in all buildings erected after passing these By-laws, intended for human occupation, the thickness of the walls shall not be less than the following:—

For one storey work (stone) all exterior walls	14in. thick
For one storey work (brick) not less than	9 "
Partition walls in stone, not less than	12 "
" " brick, " " " " " "	4½ "
Cellar walls, for house of one storey	20 "
For two storeys not less than	24 "
First storey walls, in stone, not less than	14 "
" " brick, " " " " " "	9 "
Ground floor carrying upper storeys in stone, not less than	20 "
Ground floor carrying upper storeys in brick, not less than	14 "

The same thickness of walls for third storey as provided for second storey.

The footings in all cases to be at least four inches thicker than the upper walls.

These By-laws were duly adopted and passed at a meeting of the North Fremantle Council, held at Mason's Hall on the 9th day of January, 1896, the whole of the Council being then present.

GENERAL REGULATIONS FOR THE WORKING, MANAGEMENT, AND USE OF THE ESPERANCE TOWN JETTY, FRAMED BY THE GOVERNOR IN EXECUTIVE COUNCIL ON THE 19TH MARCH, 1896, IN ACCORDANCE WITH THE PROVISIONS OF "THE JETTIES REGULATION ACT, 1878" (42 Vic., No. 18).

1. All other Regulations for the management and use of the Esperance Town Jetty are cancelled from this date.

2. The Esperance Town Jetty shall in future be under the control and management of the Customs Department.

3. Owners of vessels and lighters using the jetty for delivering or receiving cargoes will be required to pay to the Officer in charge, in respect of berthing dues—

One penny per ton of 2,240lbs.

Minimum—5s. per vessel, 2s. 6d. per lighter.

4. Consignees and shippers will be required to pay a charge of 1s. 6d. per ton on all goods landed or shipped at the jetty; such charge including all labour in trucking on the jetty; the tonnage to be computed according to the undermentioned scale:—

 Bulls and Steers, @ 9d. each.
 Cows and Heifers, @ 9d. each.
 Pigs, @ 1d. each.
 Sheep, @ ½d. each.
 Carriages, 6s. each.
 Drays (4 wheeled), 6s. each.
 Buggies, Dogcarts, Drays (2 wheeled), and Traps, &c., @ 4s. each.
 Minimum charge for any package, 6d.
 Under ½ ton, 6d.
 Over ½ ton, at rate of 1s. 6d.

All goods not enumerated in the foregoing scale to be charged at 1s. 6d. per ton of 40 cubic feet, or in cases of dead weight, 1s. 6d. per ton of 2,240lbs.

Passengers embarking or disembarking will not be required to pay jetty dues on personal baggage when trucked up or down the jetty.

5. Jetty dues on all goods must be prepaid before they are removed.

6. Before commencing to discharge inward cargoes, ship masters or their agents shall hand to the Officer in charge of the jetty a freight list of the cargo, which shall include mark, number, shipper, consignee, weight, or measurement.

7. No goods shall be placed on the jetty without permission of the Officer in charge.

8. If free goods are not removed from the receiving warehouses within 24 hours from the time they are placed therein, a storage charge of 6d. per ton, or 1d. per package per day, will be made.

9. Cargoes trucked direct into receiving warehouses shall be tallied; and the Officer in charge shall, if requested, give receipts for same.

10. The official hours for trucking will be from 6 a.m. to 5 p.m. between 1st October and the 30th April, with an interval of one hour each for breakfast and dinner; and on Saturdays the hours will be from 6 a.m. to 1 p.m. From 1st May to the 30th September, 8 a.m. to 5 p.m., with an interval of one hour only for dinner; and on Saturdays from 8 a.m. to 1 p.m.

11. No vessels, boats, or flats shall be fastened to any part of the jetty, except to such ring-bolts or other fastenings as are or may be provided for the purpose; and no vessels, boats, or flats shall lie alongside the jetty unless so fastened. All vessels, boats, or flats so fastened shall also be anchored or moored in such manner as to relieve the jetty as much as possible from the weight of such craft; and in no case shall more than *one tier* of such vessels, boats, or flats lie alongside or be fastened to the jetty, or be moored or fastened to other vessels, boats, or flats lying alongside the jetty, except on special permission of the Officer in charge of the jetty.

12. Such vessels, boats, or flats shall not be moored or so fastened as aforesaid, except for the purpose of loading or unloading, nor for any longer period, during the authorised hours, than shall be reasonably required for such purpose.

13. Passenger boats only may lie alongside the steps on the jetty, and for no longer period than may be necessary to embark or disembark passengers.

14. All such vessels, boats, or flats lying alongside the jetty shall, on the approach thereto of a passenger steamer, be hauled off to a sufficient distance to enable her to disembark or embark passengers.

15. No person shall fish on the jetty to the obstruction of the traffic.

16. Stones, bricks, clay, sand, lime, coals, coke, or other fuel (except in bags) shall not be landed or placed on the jetty, except imported bricks or paving stone, both which latter must be removed immediately. Firewood, for the use of passenger steamers and other vessels or boats shall be taken direct from the truck to the vessels. No goods shall be handed over the rails of the jetty.

17. Tramways and trucks provided for the use of the jetty shall, where so provided, be used for the transit of goods, chattels, and merchandise, on, to, and from the jetty. Bullock or horse teams, or any wheeled vehicle drawn by any quadruped or quadrupeds, shall not be driven on or permitted to go on the jetty.

18. Explosives shall not be landed or left on the jetty without a keeper, nor without being well covered with a tarpaulin, and shall be removed with all possible despatch.

19. All goods trucked on the jetty must be carefully removed from the trucks, and not shot off them.

20. No stones or other kind of substance whatever shall be thrown into the water from the jetty.

21. No person shall make fast any tackle, purchase, or other gear to any part of the cranes placed at the ends of the jetty, except such gear as is furnished by the Government for the working of the crane.

22. Not more than one ton shall be lifted with single half-inch chain, or two tons with a single block added. On a single five-eighth chain not more than 33cwt. shall be lifted, or 66cwt. with one single block added. For heavier weights the number of parts of the chain shall be increased in proportion to the weight to be lifted; but not more than five tons shall be put upon any crane without special arrangements with the Officer in charge of the jetty.

23. Any steam vessel plying on the coast of this Colony shall be permitted to lie alongside the jetty, for the purpose of discharging and taking in cargo, at all hours of the day and night consistently with the Regulations.

24. All steamers when lying at the jetty shall have and use two up-and-down fenders made of rope, and outside the up-and-down fenders a fore and aft rope fender of sufficient length and thickness to keep the guard streak entirely clear of the fender piles.

25. No goods are to remain on the jetty for more than 24 hours, or on the platforms for more than 48 hours.

26. In cases where special permission is granted by the Sub-Collector or other principal officer of Customs for the landing of goods from beyond the seas on the beach, no wharfage charges will be levied, such as are chargeable on goods landed at the jetty.

27. When the Officer in charge of the jetty may deem it unsafe, through stress of weather, for a vessel to remain alongside the jetty, he shall direct the immediate removal of such vessel.

28. All foreign-going vessels shall be moored alongside the jetty, in such position as may be indicated by the Officer in charge, who will, if necessary, direct the removal of other craft for that purpose.

29. Vessels shall unload in the order in which they arrive, and are placed in a list to be kept by the Officer in charge of the jetty. Application, to be placed in turn on such list according to arrival, must be made to the Officer in charge on the day preceding that on which the vessel will unload. If such application be not made the next vessel on the list shall have precedence, but the vessel forfeiting her turn may be placed next in succession. Vessels will load according to the order of application to the Officer in charge, and shall, when required by him, give place to vessels discharging cargo. Mail steamers and vessels arriving from or bound to foreign ports shall have precedence of coasting and other craft.

30. In the event of any vessel or vessels being moored alongside the jetty in such way as to exclude any other vessel or vessels whose owners or masters wish also to moor her or them alongside consistently with the Regulations, the Officer in charge of the jetty has power hereby to order the removal of such vessel or vessels to another berth or berths, and thus afford a berth or berths for such vessel or vessels so wishing to moor alongside such jetty.

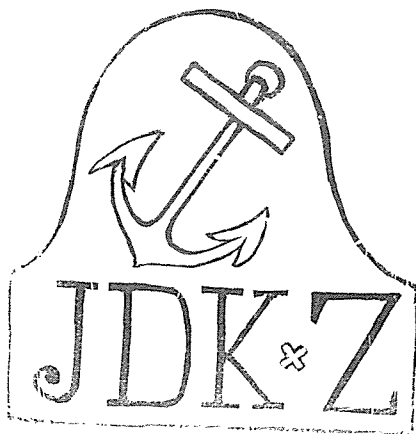

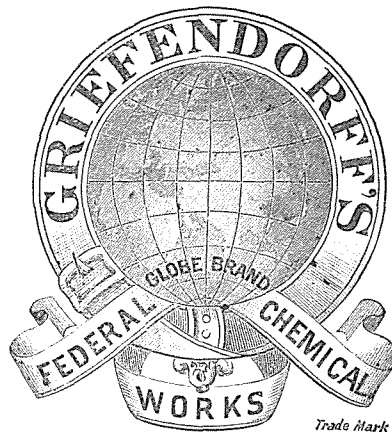

RESERVE.

Department of Lands and Surveys, Perth, 20th March, 1896.

HIS Excellency the Governor in Executive Council has been pleased to set apart, as a Public Reserve, the land described in the Schedule below, for the purpose therein set forth:—
