WHEREAS by the provisions of "The Elementary Education Act, 1871, Amendment Act, 1893," the Governor is empowered, by Proclamation in the *Government Gazette*, to constitute Educational Districts, and define and alter the boundaries of any District: Now THEREFORE I, the Governor aforesaid, with the advice of the Executive Council, do hereby alter the existing Boundaries of the Plantagenet District Board of Education, and do declare them to be as set forth in the following Schedule.

PLANTAGENET EDUCATIONAL DISTRICT.

Bounded on the *Northward* by the South bank of the Gordon River upwards to its intersection with the East boundary of Reserve 875, near the Gordon Bridge, thence by an Easterly line passing through the South-West corner of Plantagenet Location 169, near Pootenup, thence North-Easterly passing through Survey Post O 11, near Kybelup Pool, in the Pallinup River, and onwards in direction of Mount Glasbe, in the Bremer Range, to a point due East

WHEREAS a certain block of land, consisting of land bounded as hereafter mentioned in the Schedule hereto, has been added to the townsite of Kalgoorlie: AND WHEREAS the said block of land is included in, and forms a portion of the East Coolgardie Goldfield: AND WHEREAS under the provisions of "The Goldfields Act, 1895," power is given to the Governor of the said Colony, by Proclamation in the *Government Gazette*, to except from occupation for mining purposes or for residence or business under any Miner's Right or Business License, any specific portion of Crown Land within a goldfield: AND WHEREAS the townsite of Kalgoorlie, as originally declared, has been so excepted: AND WHEREAS it is deemed expedient to except the addition since made thereto: Now THEREFORE I, Lieut.-Colonel Sir

GERARD SMITH, K.C.M.G., Governor as aforesaid, do, with the advice and consent of the Executive Council, by this my Proclamation, except the said block of land from occupation for mining purposes or for residence or business under any Miner's Right or Business License, the said block of land being a specific portion of Crown Lands within a goldfield, to wit, East Coolgardie Goldfield: AND I do order all persons, from and after the date of the publication of this my Proclamation in the *Government Gazette*, to take notice hereof and govern themselves accordingly.

HIS Excellency the Governor in Executive Council has been pleased to confirm the following By-laws made by the Council of the Busselton Municipality.

By-Laws of the Busselton Municipality.

PURSUANT to "The Municipal Institutions Act, 1895," Sec. 99, the following By-laws were adopted by the Busselton Municipal Council on Monday, 18th day of May, 1896, the Mayor and five Councillors being present.

BY-LAW No. 1.—*Interpretation.*

In these By-laws, unless the context otherwise requires,—

1. The word "Council" shall mean the Mayor and Council of Busselton.
2. The word "Municipality" shall mean the Town of Busselton.
3. The word "Mayor" shall mean the Mayor of the Municipality.
4. The words "public street" shall mean and include every public street, road, footway, square, thoroughfare, or other place within the Municipality.
5. The word "person" shall include a body corporate.
6. The word "owner" shall apply to every person in possession or receipt either of the whole or of any part of the rents or profits of any house, building, land, or tenement.

BY-LAW No. 2.—*Standing Orders.*

ORDER OF PROCEEDINGS.

1. The Council shall meet at the Working Man's Association, on the first Wednesday in every month, at the hour of 8 p.m., for the transaction of their ordinary business, and the business of the Council shall be conducted with open doors.

WITHDRAWAL OF STRANGERS.

2. Any two members may require the Council Chamber to be cleared of strangers, and the Mayor or other presiding Chairman shall immediately give directions to have the order executed.
3. The Council shall commence business so soon after the above-mentioned hour as there is a sufficient number of members in attendance to constitute a quorum, but if at the expiration of thirty minutes from the above-mentioned hour there is not a quorum present, no business shall be transacted by the Council at that meeting.
4. Should the Mayor not be present, the meeting shall elect a Chairman from the Councillors present, who shall preside during the absence of the Mayor.
5. At all meetings of the Council when there is not a quorum present, or when the Council is counted out (which counting out shall take place whenever there shall be less than one third of the members of the Council present, exclusive of the Mayor or Councillor chosen to preside in his absence), such circumstance, together with the names of the members present, shall be recorded in the minute book.
6. At all meetings of the Council the minutes of any preceding meeting not previously confirmed shall be read as the first business in order to their confirmation, and no discussion shall be permitted thereupon except as to their accuracy as a record of the proceedings.
7. Immediately after the confirmation of the minutes the Mayor may make any communication to the Council which he may deem advisable, or bring under consideration any business he may think necessary, and it shall be competent for any member of the Council to ask a question or questions, but he shall confine himself to the question simply, and no debate shall issue thereon at that time.
8. The ordinary business shall then be proceeded with.

ORDERS OF DEBATE.

9. Any member proposing a motion or an amendment shall, if the Mayor so desire it, put it in writing and sign and deliver it to the Mayor or other presiding Chairman for the time being after it has been duly seconded, and the Mayor or other presiding Chairman shall read the same before being discussed, and no motion or amendment so made shall be withdrawn without leave of the Council.
10. No member shall speak twice upon the same question, except by way of explanation or in reply upon any original motion of which he may have been the mover, or as the mover of the amendment last carried. Nevertheless,

any member who may have been misrepresented or misunderstood shall be allowed to explain immediately before the mover rises to reply. The amendment of the original motion, as the case may be, shall be immediately put to the vote.

11. The Mayor or other presiding Chairman shall, without waiting for the interposition of the Council, call to order any member proceeding to speak a second time on the same question, unless entitled to reply or in explanation where he has been misrepresented or misunderstood.

12. Any member moving a motion or amendment shall be held to have spoken on that question.

13. No member shall digress from the subject matter of the question under discussion, or impute improper motives to any other member.

14. The Mayor or other presiding Chairman, when called upon to decide a point of order or practice, shall state the rule or precedent applicable to the case without argument or comment, and his decision shall be final in that particular case.

15. One amendment only shall be discussed at one time, but, if lost, another may be moved before the original question is put to the vote, but upon any amendment being carried it shall be competent for any member to move one other amendment thereon, but no more.

16. Upon the adoption of any amendment, such amendment shall be held to have quashed the original motion, and for all purposes of subsequent discussion the amendment so carried shall be acted on as an original motion.

17. No motion, the effect of which, if carried, would be to rescind any motion which has already passed the Council, shall be entertained during the same municipal year unless by consent of at least four members of the Council.

18. In case of an equality of votes the Mayor or other presiding Chairman shall give a casting vote, and any reasons stated by him shall be entered in the minutes and proceedings.

19. No By-law shall be finally passed or rescinded at the meeting at which it shall have been first proposed, nor until the next or some subsequent meeting of the Council duly convened.

BY-LAW No. 3.—*Suspension of Standing Orders.*

In cases of urgent necessity, any standing order or orders of the Council may be suspended on motion duly made and seconded without notice, provided that such motion has the concurrence of at least four members of the Council.

BY-LAW No. 4.—*Election of Officers.*

1. When any office is at the disposal of the Council, at least ten clear days' notice shall be given by advertisement in one or more of the local newspapers of the intention of the Council to fill such vacancy, and the same notice shall invite applications for the office, to be sent into the next meeting of the Council.

2. The salary or allowance attached to all offices at the disposal of the Council shall be fixed for the municipal year, and in all cases before proceeding to the election.

3. At the next meeting of the Council, after the notice as before mentioned has been given, all letters of application for the office shall be opened, and the names read aloud, and the appointment may then be made.

4. All election for officers at the disposal of the Council shall be effected by voting by ballot, and it shall be a general rule that the two candidates polling the largest number of votes be again put to the ballot until one of such candidates shall have polled the majority of the votes of the members present, every member present being required to record his vote.

5. No member of the Council, nor any auditor of the Municipality, nor any officer thereof, shall be received as surety for any officer appointed by the Council, or for any work to be done for the Council, and in all cases in which security for the due and faithful performance of any duty or contract is required, the expense of preparing such security shall be borne by the Council.

BY-LAW No. 5.—*Municipal Rates.*

All Municipal rates after the current year shall be payable half-yearly, and the Collector for the time being duly appointed by the Council shall, at the commencement of each half-year, leave with the person liable to pay the same, or at his residence, or post to his last known address, or affix upon the property rated, a notice of the amount due by such person, and requiring payment thereof within fourteen days, and shall afterwards apply personally for payment of the same, and if the amount be not paid at the expiration of fourteen days after such application, shall take legal proceedings for its recovery.

BY-LAW No. 6.—*Officers of the Council.*

THE COLLECTOR.

1. The Collector for the time being duly appointed by the Council shall demand, collect, and receive all rates, assessments, license fees, fines, forfeitures, rents, tolls, and other sums due to the Council, and his receipt shall be a full and sufficient discharge for any sums paid to him; and all sums so received by the Collector shall by him be paid to the Treasurer of the Council weekly.

THE CLERK OF THE COUNCIL.

2. The Clerk of the Council shall keep the books of the Council, and shall duly keep and enter in a proper minute book minutes of all proceedings of the Council. He shall attend all meetings of the Council, issue notices of all meetings, and shall prepare for the Council or Mayor thereof, and in due time, the Voters Lists for the Municipality, and cause them to be affixed as by "The Municipal Institutions Act, 1895," required, and shall supply copies thereof as by the said Act required, and shall make up and complete, under the direction of the Council, the rate book, and shall, under the like direction, prepare the Annual Estimates, as by the said Act required. He shall also keep all such books of account as required by the said Act. He shall also, under a like direction of the said Council, cause the accounts of the said Council to be balanced half-yearly as required by the said Act. He shall also, under the direction of the Council, prepare the Annual Financial Statement and summary, and shall do and perform all such other acts as the Council or Mayor thereof may lawfully require him to do under or by virtue of the said Act, and shall attend the Council Office during such hours as the Council may determine.

3. The custody of the journals, and all documents whatsoever (except such documents as are hereinafter expressed to be kept by the Mayor) laid before the Council shall be in care of the Clerk, who shall neither take, nor permit to be taken, any such journals or documents from the Mayor's or Council Office without the express leave or order of the Council.

THE MAYOR.

4. The Mayor shall have the custody of the Common Seal, and of all deeds and records of the Council; but he shall not affix the Common Seal to any corporate document without the express order of the Council.

THE TREASURER.

5. The Treasurer shall receive weekly from the Collector all sums stated to be received by him under By-law No. 6, Section 1, and give the Collector a receipt for such moneys.

6. The Treasurer shall (if required by the Council at any time so to do) give a bond, with two sureties, in a sum to be named by the Council, conditioned for the fair and diligent discharge of his duties.

7. The Treasurer shall, out of the moneys received by him as the Treasurer of the Council, pay all accounts duly and lawfully passed by the Council at its ordinary monthly meetings, and shall make all other payments which the Council may lawfully pass and order for payment.

8. The Treasurer shall pay all sums of money received by him into the credit of the Council's general account, at a bank to be named by the Council, once at least in every week.

BY-LAW No. 7.—*Slaughter Houses.*

No slaughter house shall be erected or used within the boundaries of the Municipality without the previous sanction in writing of the Council, and any person offending against this By-law shall forfeit and pay, on conviction, a penalty not exceeding £20.

BY-LAW No. 8.—*Pigs.*

No person shall keep any kind of living swine within the Municipality. Any person offending against this By-law shall forfeit and pay, upon conviction, a penalty not exceeding £2 for every such offence.

BY-LAW No. 9.—*Damaging Property, &c., of Municipality.*

Any person who shall (without first having obtained the sanction in writing of the Council) break up, cut down, damage, destroy, or injure, or remove or carry away any footpath, tree, plant, post, fence, gate, drain, watercourse, culvert, jetty, wharf, building, dead bush in use for the purpose of arresting drift sand, or other property belonging to or in charge of or under the possession, control, or power of the Council shall forfeit and pay, upon conviction, a penalty not exceeding £10 for every such offence.

BY-LAW No. 10.—*To prevent Danger from Fire.*

Any person who shall (without first obtaining the permission in writing of the Mayor), anywhere within the

limits of the Municipality, light any unguarded fire, or set fire to any straw, wood, or rubbish, or make any bonfire, or let off any fireworks, shall forfeit and pay, upon conviction, a penalty not exceeding £5 for every such offence.

BY-LAW No. 11.—*Roof Gutters, Down Pipes, and Drains.*

The owner or occupier of every house, shop, verandah, balcony, or other building, in, adjoining, or near to any street or any public way, shall within seven days next after service of a notice by the Council for that purpose, put up a sufficient shoot or gutter to the whole length of such house, shop, verandah, balcony, or other building, and shall connect the same with suitable down piping, fixed to the front or side of such building from the roof to the ground in such manner that the water from such building shall not fall upon persons passing along the street or public way, or flow over the footpath or roadway, but shall be conducted under the footpath by means of a pipe of such material and in such manner as shall be directed by the Council, and shall be at sufficient depth as to cause no obstruction to persons passing over, and shall be connected with the gutter or channels at edge of footpath or roadway, and in default of compliance with such notice within the period aforesaid, or with the provisions of this section, such owner or occupier shall forfeit and pay a sum not exceeding £10.

BY-LAW No. 12.—*To prevent the Danger from the Driving of Vehicles at Night.*

Any person who, between any sunset and the following sunrise, shall in, upon, or along any of the public streets within the Municipality, drive any vehicle except at a walking pace, without having a lamp or lantern securely fixed on each side of the front of such vehicle, shall forfeit and pay, upon conviction, a penalty not exceeding £5 for every such offence.

BY-LAW No. 13.—*Quarries and Timber.*

Any person who shall quarry stone, raise marl or sand, or cut firewood or timber on the lands belonging to, or in charge of, or under the possession, control, or power of the Council without a license therefor, shall forfeit and pay, upon conviction, for every such offence a penalty not exceeding Forty shillings.

BY-LAW No. 14.—*Schedule of Licenses and Fees to be paid yearly in advance on or before 31st January, or immediately on such Live Stock or Carriages being kept within the Municipality.*

For milch cows, 5s. per head.

For horned stock over six months and under twelve months, 2s. 6d. per head.

For every carriage of two wheels, 10s. each.

For every carriage of four wheels 20s. each.

Provided that if any such stock be not depastured before the 1st day of July in any year, then the license fee in respect thereof for that year shall be half only.

Stone, marl, and sand, 6d. per cubic yard.

Wood, 6d. per cord.

Any person failing to pay the License as stated in the above Schedule, shall forfeit and pay, upon conviction, a penalty not exceeding £2 for each offence.

BY-LAW No. 15.—*Impounding.*

All unlicensed animals roaming or depasturing within the limits of the Municipality at any time during day or night, and all horned stock found in the streets after 8 p.m., and before sunrise, shall be impounded. All impounded animals shall be subject to a charge on the following scale of poundage fees:—

Such fees to be paid for each day or part of a day during which any such animal shall be in the pound.

For the proper sustenance of impounded horses, cattle, sheep, &c. The poundkeeper shall be empowered to charge the following rates:—

For each horse, mare, gelding, mule, ass, camel, pony, or head of horned cattle, above 12 months old, 2s. 6d.

For colt, foal, or head of horned cattle under twelve months old, except sucking foals or calves, fed on hay or chaff, 1s. 6d.

For pig, 1s.

For sheep, or goat, fed on hay or chaff, 3d.

Such rates to be charged for every day of twenty-four hours, half rates only to be charged for less than twelve hours, and no charge to be made for less than three hours.

Country stock may be impounded in the town pound subject to the scale of poundage fees, charges for sustenance, and regulations made by the Justices of the Sussex district under "The Cattle Trespass, Impounding, and Fencing Act of 1882." Such fees and charges being payable to the poundkeeper appointed by the Municipality.

BY-LAW No. 16.—Number of Stock to be run on Commonage.

No person or business firm shall run a greater number of stock than the numbers stated below:—

Horned stock of any age	20 head
Goats	3 "
Horses	10 "
Sheep	50 "

Any person who shall run more stock on the Busselton Commonage than is allowed by this By-law shall forfeit and pay, upon conviction, a penalty not exceeding £2 for every offence.

BY-LAW No. 17.—Erection of Tents, Pavilions, &c.

Any person who shall erect a tent, pavilion, shed, or other structure of canvas or inflammable material within the Municipality without first receiving the consent of the Mayor or Council in writing shall forfeit and pay, on conviction, a penalty not exceeding £2 for every such offence.

BY-LAW No. 18.—Horses.

1. No person shall break in any horse in the streets either by leading, riding, or driving.

2. No person shall allow any mare to be covered, except in yards properly enclosed, without the consent of the Council in writing. Any person offending against any portion of this By-Law shall forfeit and pay, on conviction, a penalty not exceeding £5 for every such offence.

BY-LAW No. 19.—Signboards, &c.

1. Any person who shall erect or place any signboards, signs, awnings, blinds, overhanging lamps, or other things over or near any footway or roadway without first obtaining the consent of the Council in writing shall forfeit and pay, on conviction, a penalty not exceeding £2 for every such offence.

2. Any person wishing to erect any balcony, verandah, or signboard over any part of a street or footway shall obtain permission of the Council in writing before so doing, and any balcony, verandah, or signboard so erected by the consent of the Council shall be at least 8ft. clear above the street or footway over which it is erected, and shall be built in a substantial manner, and shall be subject to the approval of the Council, both with respect to its strength and appearance; and, further, the Council will have power to remove or cause to be removed any balcony, verandah, or signboard now erected, or that may be hereafter erected, over any street in the Municipality not being erected in conformity with this By-law, provided that the owner or occupier of the premises to which any such balcony, verandah, or signboard is or may be attached shall have received 14 days' notice in writing from the Council to remove such balcony, verandah, or signboard, and any owner or occupier failing to remove such balcony, verandah, or signboard after having received the said notice shall forfeit and pay, upon conviction, a penalty not exceeding £10, together with all expenses (if any) incurred by the Council in removing any such balcony, verandah, or signboard.

BY-LAW No. 20.—Obstruction of Streets and Footpaths.

1. Any person who shall obstruct any street or footway within the Municipality by placing any stone, bricks, timber, or any other building material, packing cases, or any other things, without first obtaining permission of the Council, shall forfeit and pay, on conviction, a penalty not exceeding £2 for every such offence.

2. Any person damaging a footpath or roadway shall be liable to pay the cost of repairing the damage to such footpath or roadway.

3. And any person placing any stone, bricks, timber, or any other building material on any footway or roadway without keeping sufficient light or lights affixed thereto, from sunset to sunrise, shall forfeit and pay, on conviction, a penalty not exceeding £2 for every such offence.

BY-LAW No. 21.—Lamp-posts, &c.

No lamp-posts, bridle-posts, or flag-staffs shall be erected by any person in any street, without the written consent of the Council, and such posts shall be placed in such position as may be directed by the Council, and shall be painted at least once in every three years, and the Council may order the removal by the owners of all bent, dangerous, or unsightly posts. Any person offending against this By-law, shall forfeit and pay, on conviction, a penalty not exceeding £2 for every such offence.

BY-LAW No. 22.—Walls and Fences.

1. No person shall erect any fence with bush, or other dangerous or inflammable substance, abutting on any public street, without first obtaining permission of the Council in writing.

2. Any fence or wall erected and abutting on any public street will be subject to the approval of the Council, and the owner of any such fence or wall shall keep and maintain such fence or wall in good order and repair, and shall remove the same if not so approved, and upon the Council ordering the removal of the same.

All fences abutting on any artificially formed footpath shall be constructed of sawn timber, and shall be subject to the approval of the Council.

All existing fences of split timber abutting on any artificially formed footpath shall be removed and replaced with sawn timber fences subject to the approval of the Council. On the order of the Council the Town Clerk, or other duly appointed officer, may direct the removal of any such split fence and cause the same to be re-erected of sawn timber at the cost and charges of the person so offending, and to proceed against the offender for the breach of this By-law, the penalty for which breach shall not be less than £1 nor more than £20 for every day or part of a day during which such offence shall be committed or continued after the expiry of the notice prescribed herein.

3. No person shall erect a fence of barbed wire abutting on any public street within the Municipality. Any person offending against this By-law shall forfeit and pay, on conviction, a penalty not exceeding £5 for every such offence.

BY-LAW No. 23.—Velocipedes, &c.

No person shall ride or place a bicycle or other velocipede upon any footpath. Any person riding or placing a bicycle or velocipede upon any street between sunset and sunrise without carrying a lighted lamp and an alarm bell attached to the front part of such bicycle or velocipede, and sounding the bell in ample time to allow foot passengers and others to protect themselves from danger, and any person riding a bicycle or other velocipede in or upon any street or roadway in a furious manner shall forfeit and pay, on conviction, a penalty not exceeding £2 for every such offence.

BY-LAW No. 24.—Throwing Dangerous Substances on Footpaths.

Any person who shall throw vegetable substances, or any offensive, noxious, or dangerous substance upon any footpath within the Municipality, shall forfeit and pay, on conviction, a penalty not exceeding £1 for every such offence.

Any person or persons placing or causing to be placed or broken in or upon any road, pathway, reserve, or park lands, under the control or supervision of the Council any glass, metal, or earthenware bottles or utensils, without having first obtained the consent of the said Council so to do, shall be liable beyond the costs and charges incidental to the removal of any such glass, metal, or earthenware, to a fine, upon conviction, not exceeding £2, in addition to amount of damages caused thereby.

BY-LAW No. 25.—Goods left in the Streets.

Any person who shall allow any goods, merchandise, coal, or firewood to remain in any street for a longer period than necessary for housing or removing the same shall forfeit and pay on conviction a penalty not exceeding £2.

BY-LAW No. 26.—Removal of Vehicles or Animals left on the Street.

Any officer of the Council or any police constable may seize and remove any animals or vehicles left unattended in any street, or obstructing any portion of any street, and the owners of any animals so seized or removed shall be liable, upon conviction, to pay a penalty not exceeding £2.

BY-LAW No. 27.—*Impure Water or Liquid Matter not to flow on any Street.*

Any owner or occupier of any house, land, or premises within the Municipality who shall allow any impure water or any liquid matter of any description to flow from such house, land, or premises, into or upon any street, footway, or gutter, and any person who shall throw or place thereon or therein any impure water or any liquid matter of any description shall be guilty of an offence against this By-law, and, upon conviction, shall pay a penalty not exceeding £5.

BY-LAW No. 28.—*For providing and maintaining suitable Closets and Urinals and for prohibiting Cesspits.*

1. The owner of every house or premises within the municipality of Busselton shall, after notice, cause to be constructed on said premises a suitable closet provided with the pans approved by the Council. Such closet shall be maintained and ventilated to the satisfaction of the officers of the Council with a proper outlet at side or back of closet for removal of cesspan, proper door for same being hung on side, and shall in no case be situated at a less distance than twenty feet from any dwelling house or place of business, except by the express permission of the Council first obtained.

2. The receptacle of every closet shall be constructed of galvanised iron, it shall be water-tight and the ground floor of the closet upon which it stands shall be cemented or otherwise made impervious, and the receptacle shall be emptied at least once a week.

3. No urinal with cesspool attached shall hereafter be constructed in the said Municipality unless the urinal is built in a substantial and suitable manner for the use required thereof, and unless the walls of the cesspool, 6in. below the level surface of the ground around it, be built of stone or concrete of the thickness, as respects stone work, of 12in., and concrete of 9in., and of the following dimensions, viz., 4 feet long, 3 feet wide, 4 feet deep, and so constructed and cemented and made water-tight. All drains connecting the urinal with cesspool to be constructed so as to be water-tight. Cesspool to be covered with a strong wood top over which a layer of earth must be placed to prevent effluvia arising therefrom. All cesspools must be emptied of their contents when notice to that effect has been duly served upon the owner or occupier of the premises, and no urinal and cesspool erected after the date of this regulation coming into operation shall, unless constructed as hereinbefore is provided, be suffered to remain after six days' notice in writing from any officer of the Municipality to remove or fill up same.

4. Every person who shall commit a breach of this By-law shall be liable to a penalty not exceeding £5, nor less than 5s., and to a further penalty not exceeding £2, nor less than 1s., for each day during which such breach or omission shall be committed or continued.

BY-LAW No. 29.—*Park Lands, Reserves, and Recreation Grounds.*

1. All park lands and recreation grounds shall be open to the public daily for recreation purposes, excepting as otherwise provided for in these By-laws.

2. The Council shall have the power to grant exclusive right to use and occupy any park lands, recreation grounds, or reserves within the Municipality for holding public sports or amusements to any responsible person or persons for any time not exceeding three days, and any person or persons obtaining such right shall be responsible for the proper care of all fences, buildings, and trees upon or enclosing such park lands, recreation grounds, and reserves, and shall pay to the Council a fee to be fixed for admission on such occasions.

3. No horses, cattle, or vehicles shall be allowed on any park land or recreation ground without the written permission of the Mayor or Council.

4. All persons using or being upon any park lands, recreation grounds, or reserves, shall at all times conduct themselves in a becoming manner, and any person creating any disturbance or annoyance to the public shall be liable to be expelled from such lands by any police constable or officer of the Council.

5. The Council may, in its discretion, prohibit any games or gymnastics from being played or carried on by any person or persons upon any park lands, recreation grounds, or reserves, on any Sunday, Christmas Day, or Good Friday.

6. No person shall sell or expose for sale any goods, wares, fruit, or merchandise in any park lands, recreation grounds, or reserves, without first having obtained the written consent of the Mayor or Council, and shall pay a fee, the amount of such fee not to exceed £10.

7. No person shall damage or injure any tree, shrub, or plant in any park lands, recreation grounds, or reserves. Any person offending against this By-law shall forfeit and pay, on conviction, a penalty not exceeding £10 for every such offence.

BY-LAW No. 30.—*Dairies.*

1. Any person or persons carrying on the trade of cow keepers, dairymen, or purveyors of milk within the Municipality shall register their names and addresses with the Town Clerk, and shall keep their milk stores, shops, or dairies, or milk vessels used for containing milk for sale, and every place used in connection therewith, in a thoroughly clean condition to the satisfaction of an officer appointed by the Council.

2. No person shall contaminate or adulterate in any way any milk offered for sale within the Municipality. Any person offending against this By-law shall forfeit and pay, on conviction, a penalty not exceeding £20 for every such offence.

OFFICER OF HEALTH.

1. It is the duty of the Officer of Health to superintend the application of all sanitary measures ordered by the Local Board, and to advise them generally in all such matters.

2. The Officer of Health shall make frequent examination of the district under his control, and to see that the duties of the inspectors are efficiently performed and report any neglect of those officers, and, if necessary, suspend any of them until such report and neglect has been considered by the Local Board.

3. He is, pursuant to the powers contained in "The Public Health Act, 1886," to inspect premises that may be reported to him, or that he may have reason to believe are in a filthy or unwholesome condition and affecting health, and, if found so, to give a certificate in accordance with Section 60 of the Act.

He is also required to examine premises where process of manufacture causing effluvia is carried on, and, if necessary, furnish the Local Board with the required certificate in accordance with Section 57.

He is also to inspect and furnish a certificate, if necessary, of any houses built for habitation, or of any overcrowding, in accordance with Sections 66 and 67.

He is also to assist the Board with his presence and advice, if necessary, in order to the carrying out of Section 31 referring to the sale of unwholesome food, and on all occasions to give them the benefit of his medical experience and skill.

4. The Officer of Health is to report to the Local Board with the least possible delay any undue prevalence of disease in his district, whether general or locally, and, in the latter case, it will be his duty to attract the attention of the Local Board to the locality in order that remedial measures may be at once taken. He is also carefully to note the appearance in his district of any epidemic, endemic, or contagious disease or indications thereof, or any occurrence or circumstance affecting or likely to involve public health, and he shall immediately make a full report thereof to the Local Board, whose duty it will be immediately to forward his report to the Central Board, in accordance with Section 35; and the Health Officer is expected energetically to assist in carrying out and enforcing the Regulations of the Central Board for mitigating, as far as possible, and preventing and checking the spread of epidemic and other diseases as detailed in Section 38.

5. The Officer of Health is to furnish the Local Board of his district, during the months of January and July in each year, with a report on the health, cleanliness, and general sanitary state of his district for that period, making any remarks and observations he may think proper.

6. The Officer of Health shall from time to time issue to the Inspector such orders and instructions as the said Health Officer may deem necessary, and the Inspector, being placed under the control of the Health Officer, is required to report to him direct upon all matters or things appertaining to their respective duties and districts.

Any special matter contained in any such reports necessary to be brought under the notice of the Local Board shall be forwarded by the Health Officer to the Local Board in the usual manner.

7. The Officer of Health shall obey the orders of the Council.

All previously existing By-laws are hereby repealed.

The above By-laws were adopted by the Council on the 18th May, 1896.

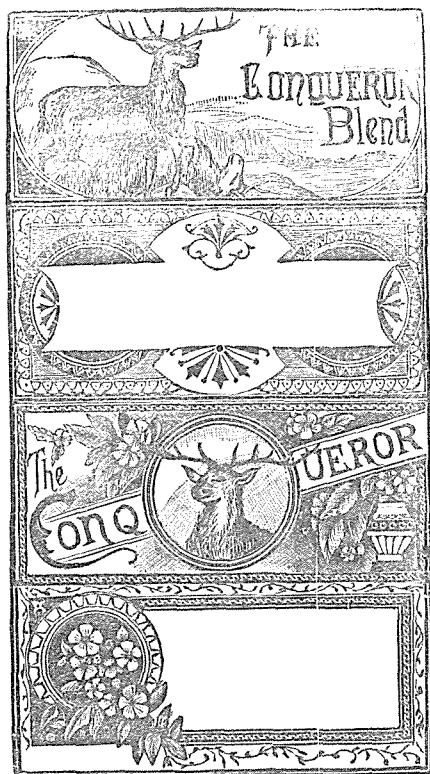
